

Educational Objective of the JPR Foundation and How KTBR AM-FM Will Be Used To Advance an Educational Program

The JPR Foundation is a not-for-profit corporation created under the laws of the State of Oregon. It has federal tax exemption status under section 501(c)(3) of the Internal Revenue Service Code. The foundation was created with the express purpose of supporting the operations of Southern Oregon University's Jefferson Public Radio (JPR) as a community based educational resource. Article 9 of the foundation's by-laws specifically state the foundation is "To encourage and promote high quality public radio for listeners throughout the Southern Oregon and Northern California region."

The JPR Foundation is dedicated to fostering the educational and cultural life of the region it serves by supporting JPR's objectives and mission. This mission includes:

- promoting informed citizen participation toward creating responsive government
- creating and fostering a climate which encourages tolerance for the expression of diverse viewpoints
- supporting and encouraging artistic creation
- providing an outlet for the discussion of issues facing minority populations

During the past year the foundation's activities have included:

- Developed and maintained JPR's web site, including providing the funds to support it's audio streaming service.
- Developed and maintained an on-line database, The Community Calendar, which allows non-profit organizations to post the details of their events on the World Wide Web and have them available to the public and broadcast on JPR.
- Created and disseminated educational materials which cross media platforms. Published and distributed two books devoted to history and science that were connected to JPR radio programs. Published JEFFERSON MONTHLY which is substantially devoted to the arts, history, politics and environment of the region.
- Presented its own concert series featuring artists such as Marcel Marceau, George Winston, R. Carlos Nakai, Jackson Browne, Paula Cole, Randy Newman, David Grisman and Pat Metheny.
- Conducted a capital fund drive and coordinated restoration of the Cascade Theatre, a 1935 historic building and former movie palace and vaudeville stage in Redding, California. The facility now includes a satellite JPR radio studio. When completed the auditorium portion of the building will serve as a multi-purpose performing arts center for the benefit of local citizens. The restoration is being carried out in a way that honors the heritage of the building and is consistent with "The Secretary of the Interior's Standards for the Treatment of Historic Properties."

The Foundation is committed to the principles of life-long education and community service. Its support of Jefferson Public Radio springs from the belief that JPR is capable of achieving major significance in furthering these goals through JPR's radio activities. Simultaneously, the

foundation has a proven and clear record of independently pursuing other avenues outside of radio to further these goals. It is the Foundation's firm purpose, in acquiring KTBR-AM-FM to assure that these stations will be used for the same purposes through an LMA agreement with Jefferson Public Radio to provide broadcast programming of that type and through corollary public service opportunities associated with KTBR-AM-FM which the foundation would continue to independently advance.

In its relationship to Jefferson Public Radio, the Foundation is dedicated to helping JPR provide programming that meets the highest standards of public service in journalism and cultural expression to JPR's coverage area. That commitment includes supporting locally originated programming which reflects the unique issues and concerns and accomplishments of the communities thus served and their changing multi-cultural make-up. Specific local program content which the Foundation will require be embodied in its proposed LMA for these stations with Jefferson Public Radio will include news, informational and call-in programs, public service announcements, and programs which promote the arts, including literature, music, and theater. In addition, programming from National Public Radio and Public Radio International will be featured on the stations.
