Quad Cities, Iowa
Multiple Ownership - Radio-Television Cross Ownership

This application seeks FCC consent to the transfer of control of Local TV Illinois License, LLC, the licensee of television station WQAD-TV, Moline, Illinois, from the members of Local TV Holdings, LLC (“Local TV”) to Tribune Broadcasting Company II, LLC, a wholly-owned subsidiary of Tribune Company (together, “Tribune”).

Oaktree Capital Group Holdings GP, LLC (“Oaktree”) has an attributable interest in Tribune through certain affiliated funds.¹ It also has an attributable interest in Townsquare Media LLC (“Townsquare”), which in turn has applied at the Commission for consent to acquire, through a subsidiary, five Quad Cities area radio stations: KQCS, Bettendorf, KJOC, Davenport, KBOB-FM, De Witt, WXLN, Moline, and KBEA-FM, Muscatine (all Iowa).² This exhibit demonstrates that the acquisition by Oaktree of an attributable interest in WQAD-TV (located within the Quad Cities Nielsen Designated Market Area) and these five radio stations (located within the Quad Cities Arbitron Metro Market) would comply with Section 73.3555(c) of the Commission’s Rules, the “Radio-TV Cross Ownership Rule.”

Upon consummation of the two proposed transactions described above, Oaktree will have an attributable interest in one television station (through Oaktree’s interest in Tribune) and five radio stations (through Oaktree’s interest in Townsquare) in the Quad Cities area.

Under the Radio-TV Cross Ownership Rule, a single entity may own a television station and up

to seven radio stations (if permitted under Section 73.3555(a), the Local Radio Multiple Ownership Rule), provided that at least 20 independently-owned media voices would remain in the market following consummation of the proposed transaction. As shown in Attachment A, at least 20 independently-owned media voices will exist in the Quad Cities market following the consummation of the proposed acquisition of WQAD-TV by Tribune and the above-referenced radio stations by Townsquare. Thus, Oaktree's attributable interests in one television station and five radio stations in the market will comply with the Radio-TV Cross Ownership Rule.
