The Special Operating Condition 1 states that:

This construction permit authorizes the mounting of an antenna on the nondirectional tower of the AM station identified below. During the installation of the antenna, the AM station shall determine operating power by the indirect method (see Section 73.51 of the Commission's Rules). Upon completion of the antenna installation, antenna impedance measurements on the AM antenna shall be made. If the resistance of the AM antenna has changed more than 2 percent from the licensed value (see Section 73.45 (c) (1) of the Commission's Rules), an application for the AM station to return to direct power measurement, including a tower sketch of the installation, shall be filed with the Commission by the AM station licensee using form 302-AM. The permittee must submit conformation of the completion of the requirements of this condition in the application for license to cover this construction permit.

Antenna Impedance Measurements

On 21 February, the antenna Impedance of Station WAME was measured, both before, and after installation of the antenna and transmission line for co-located station WWRO-LP. The following values were recorded.

Before installation:

Resistance = 13.9 Ohms, Reactance = -j122 Ohms These values agree closely with the Licensed values.

After installation of the FM antenna and transmission line, the antenna impedance was again measured.

After installation:

Resistance = 14.5 Ohms, Reactance = -j114.2 Ohms

The measurements were made using a General Radio Model 1606 RF Impedance Bridge and a Potomac Instruments SD-31 Rf Synthesizer-Detector.

The measurements were confirmed using a Delta Electronics model OIB-1 RF impedance Bridge, and the Potomac SD-31 Synthesizer- Detector. Accuracy of the measuring equipment is periodically verified by measuring the value of a series of precision value resistors and reactances.

As is common with attachments added to an AM radiator, the Resistance and Reactance values of the WAME Antenna were changed by the installation of the WWRO antenna system. As FCC Rules require that a change of Antenna Resistance of more than 2 percent from the Licensed value requires filing of an FCC 302-AM, WAME will need to file a 302-AM, as both the Resistance and

Reactance values were changed by more than 2 percent.

I certify by this narrative that I personally made the measurements contained herein. The measurements were witnessed by Mr. Robert Caskey, Chief Engineer of WAME. I attest that I am a technical consultant with more than 40 years of experience in the design, construction, and maintenance of AM, FM and TV transmission equipment, and that I have made measurements similar to these for submittal to the Commission on numerous occasions, and that I am qualified to make these measurements.


