**Television Duopoly Statement**

Pappas Telecasting of Central California, L.P. (“Pappas”) is seeking authority to acquire Station KFRE-TV, Sanger California from Sanger Telecasters, Inc. Station KFRE-TV is licensed to the Fresno-Visalia Designated Market Area. Pappas Telecasting Incorporated is the licensee of Station KMPH(TV), Visalia, California, which also is located in the Fresno-Visalia DMA. Mr. Harry J. Pappas is the majority (99%) shareholder of Pappas Telecasting Incorporated, and is one of the General Partners of Pappas Telecasting of Central California, L.P. with a 51% equity interest. As such, the proposed common ownership of Station KFRE-TV and KMPH(TV) (the “Stations”) must comply with Section 73.3555(b) of the Commission’s rules.

In order to comply with Section 73.3555(b), Pappas must demonstrate that (i) at least one of the stations subject to the proposed combination is not in the top four stations in the DMA, and (ii) there will remain, post-merger, at least eight independently owned and operated full power television stations in the DMA whose Grade B signal contours overlap with the Grade B signal of either of the stations subject to the proposed combination. If more than one station is currently owned by an entity, or an application seeking authority for common ownership of two stations in the DMA is pending, then that combination of facilities is counted as one “voice.”

According to the May 2003 Nielsen reports, only one of the Stations, KMPH, was ranked as one of the top-four television stations in the market.

As shown in Appendix A to this Exhibit, Smith and Fisher conducted an engineering study to determine the number of Grade B contours that overlap with the proposed station combination (the “Engineering Statement”). According to the Engineering Statement, there currently are 10 other operating stations licensed to the Fresno DMA whose Grade B contours overlap with either or both KMPH or KFRE-TV. A review of the Commission’s files reflects that, including KMPH and KFRE-TV, there are currently 12 stations in the DMA owned by eleven independent voices:
