The Stephens Family Limited Partnership (“SFLP”) is the owner of all of the other subsidiaries listed beneath it in the list set forth above, which, in turn (with one exception) are the ultimate licensees of the broadcast radio stations that are the core of the organization’s business operations. The only subsidiary that is not the licensee of one or more broadcast stations is Stephens Media Group – New York, LLC (“SMGNY”), which acts as a holding company for the various New York station groups. A new LLC, Stephens Media Group – Rochester, LLC (“SMGR”), has been formed to hold the licenses of the Rochester-area FM stations (WRMM, WFKL and WZNE) that are the subject of the instant FCC Form 314 application for consent to assignment.

KXOJ, Inc. is the licensee of: KYAL(AM) (Facility I.D. # 35974) and KXOJ-FM (35976), both Sapulpa, OK; KEMX(FM) (35973), Locust Grove, OK; KEOJ(FM) (35975), Caney, KS; KTFR(FM) (41636) Chelsea, OK, KCXR(FM) (64514), Taft, OK, KITO-FM (17034), Vinita, OK, and KGND(AM), Vinita, OK.

KMMY, Inc. is the licensee of KBIX-AM (14893), Muskogee, OK and KYAL-FM (35141), Muskogee, OK.

Stephens Media Group – Watertown, LLC (“SMGW”) is the licensee of WFRY(FM) (71094), WCIZ (FM) (153), WTNY(AM) (154), and WNER(AM), all Watertown, New York.

Stephens Media Group – Massena, LLC (“SMGM”) is the licensee of WRCD(FM) (15821), Canton, NY, WVLF(FM)(60470), Norwood, NY and WMSA(AM), (97) Massena, NY

Stephens Media Group – Ogdensburg, LLC (“SMGO”) is the licensee of WPAC(FM) (77827), Ogdensburg, NY, WYSX(FM) (49708), Morristown, NY and WNCQ-FM (3410), Canton, NY.

Michael P. Stephens is the sole general partner of the Stephens Family Limited Partnership (“SFLP”), and owns a 1% equity share in the partnership as a result of his general partnership status, and a 17.82% limited partnership share. Also owning limited partnership shares in SFLP are David P. Stephens (80.05%) and Tina K. Stephens (1.13%). Michael P. Stephens is the President of KXOJ, Inc. and KMMY, Inc. David P. Stephens is the Vice-President and Secretary of both companies. David P. Stephens and Michael P. Stephens are Co-Managers of SMGNY, SMGW, SMGM and SMGO. They will function in the same capacity in SMGR.
