The proposed site is contained entirely inside the service contour of second-adjacent stations WAYP.C, Marianna, FL and WFSW Panama City, FL

WAYP.C

The proposed site is contained entirely inside the service contour of second-adjacent station WAYP, 202C2, 70kW, Marianna, FL. The level of least arriving protected F(50,50) signal at the proposed transmitter site is 68.7-dBu. Using the Undesired-to-Desired method for calculating proposed interference, the interfering contour is 108.7-dBu (free-space contour method employed). The interfering contour would, in the worst case at the maximum radial, extend 131 meters, or .131km from the base of the tower. This tower is located in a very sparsely populated area and attached is a portion of the USGS Panama City, FL Quadrangle with the interference area marked in yellow. Because there are no residences, businesses or the major roadway located within this interfering contour, Calvary Chapel of Twin Falls, Inc. respectfully requests a waiver of the FM translator contour overlap regulations with respect to second-adjacent channel station WAYP.C.

WFSW

The proposed site is contained entirely inside the service contour of second-adjacent station WFSW, 206C1, 100kW, Panama City, FL. The level of least arriving protected F(50,50) signal at the proposed transmitter site is 70.3-dBu. Using the Undesired-to-Desired method for calculating proposed interference, the interfering contour is 110.3-dBu (free-space contour method employed). The interfering contour would, in the worst case at the maximum radial, extend 109 meters, or .109km from the base of the tower. This tower is located in a very sparsely populated area and attached is a portion of the USGS Panama City, FL Quadrangle with the interference area for WAYP.C marked in yellow. Because there are no residences, businesses or the major roadway located within this interfering contour, Calvary Chapel of Twin Falls, Inc. respectfully requests a waiver of the FM translator contour overlap regulations with respect to second-adjacent channel station WFSW.


