This is in reference to the request filed November 1, 2013, on behalf of Just Because, Inc. ("JBI"). JBI requests extension of special temporary authority ("STA") to operate Station WGFP(AM) with temporary facilities.¹ In support of the request, JBI states that the Commission granted an experimental AM broadcast station construction permit to Worldwide Antenna Systems LLC on May 6, 2013. The notification of completion of construction and commencement of operations with respect to the experimental AM broadcast station was filed on June 19, 2013 and the covering license application with respect to the construction permit was submitted on June 27, 2013. The experimental high efficiency broadband antenna continues to be operated pursuant to the experimental authorization issued by the Commission, with the result that an extension of the April 26, 2013, STA issued with respect to WGFP(AM) is required.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly

¹ WGFP(AM) is licensed for operation on 940 kHz with 1 kilowatt daytime and 4 watts nighttime, employing a nondirectional antenna (ND-2-U).

beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WGFP(AM) may operate from its licensed site with the following facilities:

Frequency: 940 KHz

Hours of operation: Daytime/Nighttime

Operating power: Not to exceed 1 kilowatt daytime/4 watts nighttime

Antenna type: Long wire

Overall height: 45 - 61 meters

It will be necessary to further reduce power or cease operation if complaints of interference are received. JBI must notify the Commission when licensed operation is restored.² JBI must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **April 23, 2014**.
