

SUPPLEMENT TO PARTIES TO THE APPLICATION

SagamoreHill Broadcasting of Alabama, LLC (“Assignee”), the proposed assignee of WBMM(TV), Tuskegee, Alabama, FCC File No. BALCT-20051206AFX, amends Exhibit 11 to the application by providing the following supplemental information:

1. The application identified Duff, Ackerman & Goodrich II, L.P. and Duff, Ackerman & Goodrich QP Fund II, L.P., as members of SagamoreHill Broadcast, LLC, parent company of the Assignee. This confirms that, at or prior to the consummation of the assignment for WBMM, the partnership agreement for each of Duff, Ackerman & Goodrich II, L.P. and Duff, Ackerman & Goodrich QP Fund II, L.P. will meet the criteria for insulating its limited partners from attribution pursuant to the criteria set forth in the Commission’s Rules.
2. The application identified DAG II Partners Fund, LLC as a member of SagamoreHill Broadcast, LLC. This confirms that, at or prior to the consummation of the assignment for WBMM, the limited liability company operating agreement for DAG II Partners Fund, LLC will meet the criteria for insulating its members (other than the company’s manager, DAG II, LLC) from attribution pursuant to the criteria set forth in the Commission’s Rules.
3. Additional ownership information is provided for the following members of Broadcast Media Group, LLC, a member of SagamoreHill Broadcasting, LLC, as identified in the application:
 - a. Each of Duff, Ackerman & Goodrich, L.P., Duff, Ackerman & Goodrich QP Fund, L.P., and Duff, Ackerman & Goodrich CD Fund, L.P. is a limited partnership in which all limited partners are insulated pursuant to the criteria set forth in the Commission’s Rules. DAG, LLC is the sole general partner of each partnership. The ownership of DAG, LLC is described in Exhibit 11 to the application as filed.
 - b. DAG GP Fund, LLC is a limited liability company comprised of one manager – DAG, LLC, and four members: John Duff (30%), Arnold Ackerman (30%), Thomas Goodrich (30%) and Richard Walsh (10%; former member).
 - c. International Christian Chamber of Commerce is a U.S., 501(c)(3) organization comprised of Dr. James Garvin, President, Tuscaloosa, AL; Linda Rios Brook, Vice President, Monument, CO; Peter S. Kent, Treasurer, Redwood City, CA; Luther J. Duda, Secretary, Melbourne, FL; Fred Trick, Director, Tuscaloosa, AL; Ken Dobson, Director, Coronado, CA; and Os Hillman, Director, Cumming, GA.
 - d. Wilcom 32, LLC is a limited liability company comprised of Walt Williams II (90%) and Walt Williams III (10%), each of Birmingham, AL.
 - e. PC Partners is a partnership comprised of Stephen Price, Mount Kisco, NY.
