Dear Mr. Friemel:

This letter is in reference to the above captioned minor change application filed by Raftt to modify station KYRO(AM) by changing the antenna system, and city of license from Potosi, Missouri, to Troy, Missouri, and the August 18, 2010, amendment to reduce nighttime power.

A preliminary review of the amended application reveals that:

1. Four of the required engineering exhibits were removed from the application when it was amended on August 18, 2010, and must be resubmitted in an amendment. All applicable exhibits that apply to the current proposal should have been included in the amendment, and any obsolete/superseded exhibits that no longer apply should be removed. For example, the following required exhibits were removed from the August 18, 2010, amendment: USGS 7.5 minute map showing the transmitter site; aerial photograph; site plat with ground system description; and the vertical plan tower sketch.
2. Page 7 of the KDKD(AM) tabulation page must be amended to correct the heading from "MEASUREMENTS FOR 25.0 DEGREES" to MEASUREMENTS FOR 85.0 DEGREES".
3. The electrical height of the radiator was given as 179.3° and 117.7 meters on the tower sketch, and as 179.3° and 117.6 meters on FCC Form 301, yet our calculations reveal a 117.6 meter radiator yields an electrical height of approximately 180.8° using FCC Figure 8 of the Commission's rules. These discrepancies must be corrected.

Further action on the subject application will be withheld for thirty (30) days from the date of this letter to allow an opportunity to amend. Failure to respond or to file an amendment will result in the dismissal of the application pursuant to Section 73.3568 of the Commission's rules.
