

§ 73.3555(a) Multiple Ownership Exhibit

Riverfront Broadcasting LLC ("Riverfront") is the licensee of KZKK, Channel 221A, Huron, South Dakota ("Riverfront") is filing this minor modification application Form 301 proposing to modify KZKK to specify operation on Channel 221C1 at Parkston, South Dakota. The applicant must demonstrate compliance with the Commission's Section 73.3555(a) Multiple Ownership Rules. The proposed KZKK modification at Parkston, SD is not located in or listed as home to any Nielsen Audio Metro. Therefore a contour based Non-Nielsen Audio Market contour method ownership study is required.

The proposed KZKK Channel 221C1 facility at Parkston overlaps principal community contours with two other full power stations owned by Riverfront. They are KORN(AM) 1490 kHz, Facility ID No. 35420 and KQRN, Channel 297C1, Facility ID No. 35503, both licensed to Mitchell, South Dakota. These are the three subject stations.

The combined principal community contours of the commonly owned stations make up the Defined Market Boundary. That boundary is shown in green on the Multiple Ownership Map included with this exhibit.

No stations with transmitters more than 92 km. from the boundary of the common overlap of subject stations will be considered. Further, no other facility of which the principle shareholders of Riverfront have an attributable interest has been considered as a market contributor unless it is a subject station in the radio market under study. There are a total of 17 stations in the Defined Market including the three subject stations.

According to Section 73.3555 (a)(1)(iii) of the Commission's multiple ownership rules, in a radio market with between 15 and 29 full power, commercial and noncommercial radio stations, a person or single entity (or entities under common control) may have a cognizable interest in not more than 6 commercial radio stations in total and not more than 4 commercial stations in the same service (AM or FM). Riverfront would have an attributable interest in one AM and two FM stations in this Defined Radio Market. Therefore, it is believed that this minor change application for KZKK Channel 221C1 at Parkston, SD is in compliance with §73.3555(a)(1) of the rules.
