\* The FCC has authorized subsidiaries of Raycom to hold television duopolies in the Hawaii DMA (KHNL, Honolulu [including its satellites] and KFVE, Honolulu) and in the Cleveland-Akron (Canton) OH DMA (WOIO, Shaker Heights and WUAB, Lorain). By *Memorandum Opinion and Order*, DA 08-523, released March 25, 2008, the FCC authorized Raycom to commonly own WTVR-TV and WWBT, both Richmond, VA, subject to a temporary duopoly waiver to divest one of the stations. Effective March 31, 2008, Raycom consummated its acquisition of WWBT. Raycom is filing, contemporaneously with the instant application, an application for FCC consent to the assignment of licenses of WTVR-TV to Community Television of Alabama License, LLC.

\*\* KHBC-TV and KOGG operate as satellites of KHNL and KTRE operates as a satellite of KLTV.

In addition to its owned stations, Raycom has an attributable interest in WFXG(TV) (3238), Augusta, Georgia, pursuant to a local marketing agreement with Southeastern Media Holdings, Inc. Raycom does not have an attributable interest in another station in the Augusta GA market.
