**TECHNICAL STATEMENT**

This Technical Statement supports the application by Abercrombie Broadcasting Company ("ABC"), licensee of AM Station WKZD, 1310 kHz, Priceville, Alabama to correct the geographic coordinates. In the process of an internal review of the station, it was discovered there was a variance between the geographic coordinates listed on the WKZD station license and the actual coordinates of the WKZD transmitter site. The correction of coordinates required is greater than 3 seconds of latitude and longitude, thereby requiring this Form 301 application.

The licensed coordinates of WKZD are North Latitude 34° 32' **32"** and West Longitude 86° 54' **14"**. The actual coordinates for WKZD are North Latitude 34° 32' **24.5"** and West Longitude 86° 54' **15.3"**. This represents a relocation of 0.23 kilometer (0.15 mile) along an azimuth of 188.2° True). No actual relocation of the facility or any other changes are proposed.

WKZD is located on an existing structure that is less than 200 feet in height. Due to the relatively short height of the tower and pursuant to the FCC's TOWAIR program and the FAA's Notice Criteria Tool, the Federal Aviation Administration was not notified regarding the correction of coordinates for this existing tower and the tower is not required to be registered with the Commission

This correction of coordinates has no effect on the coverage of Priceville, Alabama, since no actual relocation is proposed (Exhibits #1A through #1C). As ABC proposes no actual site change for WKZD, the allocation clearance for the station was not reviewed, but an allocation printout is attached as Exhibit #2.

Since this application reflects a correction of coordinates only and no actual changes to the tower structure or ground system are proposed, no allocation study, photos or property plat are included with this application. It is believed that the property plat submitted with the original WKZD application remains accurate. Exhibit #3 details the compliance of WKZD's operation with the FCC regulations concerning human exposure to radio frequency radiation.

ABC and/or its principals have an attributable interest in WKZD and WQAH-FM, Channel 289A, Addison, Alabama in the radio market. Pursuant to §73.3555(a)(1)(iv) of the Commission's multiple ownership rules, the combination of one AM stations and one FM station in a market is in compliance with the rule. All other necessary documentation used to certify the technical portion of FCC Form 301 has been forwarded to ABC and is available to the Commission upon request.<sup>1</sup>
