

**EXHIBIT 10**

Capitol Broadcasting Association, Inc. (“CBA”), licensee of Noncommercial Educational Station KMFA (FM-NCE), Austin, Texas, is a non-stock, non-profit organization. CBA is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of CBA’s new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The FCC first approved the board of CBA in FCC File No. BPED-19790326AD, which was renewed on September 24, 1997 in BRED-19970328WL. The Board Members in 1979 and during each of the years after the last renewal application was granted are set forth in the chart below. The chart reflects the board members as they existed following the annual business meeting each year.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. Each Board Member has one vote. None have any interests in any mass media other than KMFA.
