

## MULTIPLE OWNERSHIP

The proposed transaction is consistent with the Commission's multiple ownership rules, including the radio contour overlap rule and the radio-television cross ownership rule, Rules 73.3555(a) and (c).

Figure 2 to the Engineering Statement of L. Robert duTreil, Sr., submitted with the application, contains the contours of the broadcast stations owned by Pedro Roman Collazo and his wholly owned entities, International Broadcasting Corporation and Southwestern Broadcasting Corporation. At present, Mr. Collazo has interests in three television stations and one FM and four AM radio stations in Puerto Rico. As shown in Figure 2, two of Mr. Collazo's stations, WVOZ(AM), San Juan, and WVOZ-FM, Carolina, have overlapping contours with WGIT, Canovanas, and thus form a radio market for purposes of the radio contour overlap rule. The Grade A contour of television station WTCV, owned by Mr. Collazo and licensed to San Juan, Puerto Rico, overlaps the 5 mV/m contour of WGIT. The other two television stations owned by Mr. Collazo, WVEO and WVOZ-TV are satellite stations with WTCV; their contours do not overlap either WTCV or radio stations WGIT, WVOZ(AM) and WVOZ-FM.

With respect to the radio contour overlap rule, Mr. duTreil's engineering statement demonstrates that without taking into account the AM stations considered to be in the market, there are sixteen commercial FM radio stations in the market. See Figure 3. Under the radio contour overlap rule, Mr. Collazo could thus own six commercial radio stations in the market, four of which could be in the same service. The acquisition of WGIT by Mr. Collazo would result in his ownership of three radio stations in the market, two of which would be in the same AM service.

According to the Commission's records as obtained from the FCC CDBS system, there are twelve AM, eight FM and six television stations licensed to San Juan. See Attachment A. Excluding Mr. Collazo's owned WVOZ(AM) and WTCV, licensed to San Juan, there are 24 independent broadcast stations licensed to San Juan, including 19 commercial and non-commercial radio stations. With the acquisition of WGIT, Mr. Collazo will own one television station and one radio station licensed to San Juan. When combined with WGIT, licensed to Canavanas, and WVOZ-FM, licensed to Carolina, Mr. Collazo will own one television station and three radio stations in the market, below the limits set forth in either Rule 73.3555(c)(2)(i) or (ii).

In consequence, his proposed ownership of WGIT is consistent with the ownership limits set forth in Rules 73.3555(a) and (c).
