PURPOSE AND SCOPE

This Engineering Statement has been prepared on behalf of Berkshire Broadcasting Co., Inc. (“Berkshire”) and Gamma Broadcasting, LLC (“Gamma”). Berkshire is the licensee of and applicant for the transfer of control of the following three broadcast facilities:

Both licensees seek to transfer the above listed facilities to Reed Miami Holdings, Inc (“Reed”). None of the parties and/or affiliated companies is presently the licensee of any other broadcast facilities in the area:

This Statement addresses the overlap of the FM 70 dBu F(50,50) contours and AM 5.0 mV/m contours of the above listed stations.

DEFINED MARKETS

Figure 1 of this Statement is a map showing the 70 dBu F(50,50) contour of all of the above listed FM facilities and the 5.0 mV/m daytime ground wave contour of all of the above listed AM facilities. As shown on that Figure, several of the contours overlap in whole or in part.

MARKET 1

Market 1 is defined by the contour overlap of four affiliated stations. The four facilities are WSBS(AM), WBEC(AM), WUPE(AM) and WBEC-FM.

MARKET 2

Market 2 is defined by the contour overlap of three affiliated stations. The three facilities are WUPE(AM), WNAW(AM) and WUPE-FM.

MARKET 3

Market 3 is defined by the contour overlap of four affiliated stations. The four facilities are WBEC(AM), WUPE(AM), WUPE-FM and WBEC-FM.

NON-AFFILIATED STATIONS IN MARKETS

MARKET 1

Figure 2 is a plot of the contours defining Market 1 and the transmitter sites and 70 dBu or 5.0 mV/m contours of some of the non-affiliated stations in the markets.

In addition to affiliated stations, the following four non-affiliated stations have transmitter sites within the contour of one or more of the stations defining the market.

MARKET 2

CONCLUSIONS

Markets 1 and 3 each have four affiliated stations and at least six non-affiliated stations in the market.


Market 2 has three affiliated stations and at least four non-affiliated stations in the market.

Thus, Markets 1 and 3 each contain a minimum of ten stations of which Reed will be the licensee of four of those facilities. Market 2 contains a minimum of seven stations of which Reed will be the licensee of three.

The assignment to Reed of the six facilities listed complies with the Multiple Ownership provisions of 47 C.F.R. §73.3555.




MULTIPLE OWNERSHIP STUDY - MARKET 2
