Fresno Free College Foundation (“FFCF”), licensee of Noncommercial Educational Station KFCF (FM-NCE), Fresno, California, is a non-stock, non-profit organization. FFCF is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of FFCF’s new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The FCC first approved the board of FFCF in FCC File No. BPED-2703, which was renewed on April 22, 1999, in BRED-19980702WB. The Board Members during each of the years from 1998 are set forth in the chart on the following page.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. Each Board Member has one vote. None have any interests in any mass media other than KFCF.
