

**EXHIBIT 4 FURTHER CLARIFICATION**

In response to a request from Commission Staff, Jefferson-Pilot Communications Company (“JPCC”), licensee of WBTV(TV), Charlotte, North Carolina (Facility ID No. 30826), further amends its pending application on FCC Form 316 proposing the *pro forma* assignment of the license of WBTV(TV) from JPCC to Jefferson-Pilot Communications/WBTV, Inc (“WBTV, Inc.”) (FCC File No. BALCT-20020318AAQ). This further amendment offers additional information regarding the directors of the parent company of JPCC and WBTV, Inc., Jefferson Pilot Corporation (“JPC”), for whom attribution exemption was requested in the pending application. (These individuals are identified in Exhibit 4 to the original application in response to Section III, Question 5(a) regarding parties to the application.)

Based on the applicant’s survey of all of the individuals holding attributable ownership interests or official positions in JPC and its subsidiaries, each of the JPC directors meets the basic character and other qualification requirements for FCC broadcast licensees.

Specifically, with regard to each of the directors listed:

- No adverse finding has been made nor has an adverse final action been taken by any court or administrative body in a civil or criminal proceeding brought under the provisions of any law related to any of the following: 1) any felony; 2) mass-media-related antitrust or unfair competition; 3) fraudulent statements to another governmental unit; or, 4) discrimination.
- No JPC director has or has had any interest in or connection with any broadcast application in any proceeding where character issues were left unresolved or were resolved adversely against the applicant or any party to the application.
- No JPC director has been denied federal benefits, including licenses issued by the FCC, as a result of conviction for possession or distribution of controlled substances pursuant to the Anti-Drug Abuse Act of 1988 (21 U.S.C. § 862).

The applicant recently has been advised that William H. Cunningham has become a director of LIN TV Corp. LIN's broadcast interests are listed on Attachment A hereto. To the best of the applicant's knowledge, no other JPC director, nor any members of their immediate families, holds an attributable interest in any broadcast station or in any cable or newspaper entities in the same market as any station owned by JPC or its subsidiaries.

On May 2, 2002, William H. Cunningham became a director of LIN TV Corp.<sup>1</sup>

**III. Miscellaneous**

LIN TV's subsidiary Primeland Television, Inc., has an attributable interest in television station WAND, Decatur, Illinois (70852), by virtue of its minority partnership interest in WAND(TV) General Partnership, licensee of WAND. (WAND is located in the Champaign-Decatur-Springfield DMA market and LIN TV does not have an attributable interest in another TV station in that market.)

In addition, LIN TV holds a 50 percent non-voting equity interest in Banks Broadcasting, Inc., which, through subsidiaries, owns and operates KWCV, Wichita, Kansas (72348) and KNIN-TV, Boise, Idaho (59363).
