

Description of Transaction and Changes in Interests

Union Broadcasting, Inc. (“*UBI*”), the proposed Transferor (UBI Original Structure) and Transferee (UBI New Structure) in the instant application, is the licensee of Stations KCTE(AM), FCC Facility ID No. 64637, Independence, Missouri, and WHB(AM), FCC Facility ID No. 6384, Kansas City, Missouri.

As more fully explained below, this application seeks FCC approval of certain ownership changes in UBI resulting from execution of a Stock Redemption Agreement dated February 9, 2007 (the “*Stock Redemption Agreement*”) which was entered into after Mr. Jerry Green, Chairman, a Director and 54% shareholder of UBI, suffered a disabling stroke. Mr. Green died on August 15, 2007. Pursuant to the Stock Redemption Agreement, UBI redeemed all shares of UBI previously held by Mr. Green. An application for transfer of control was not submitted, and FCC approval was not obtained in advance of the ownership changes due to inadvertent oversight. Licensee regrets the error, but respectfully submits that the public interest would be served by grant of this application *nunc pro tunc*.

With the exception of Mr. Green’s resignation as Chairman and a Director of UBI, and a reduction in the number of directors from nine to three, there has been no change in the officers of UBI, and UBI shareholders who have previously been passed on by the Commission still vote approximately 82% of the voting shares of UBI.

On December 1, 2003, the FCC approved the officers, directors and shareholders of UBI listed under “Original Structure” in the first chart below. At present, as a result of the Stock Redemption Agreement and minor equity investments of additional shareholders (who account for only 18.4% of the voting shares), the current ownership structure of UBI is listed under “New Structure” in the second chart below:

Although UBI now recognizes that it should have obtained FCC approval in advance of the foregoing ownership changes, UBI emphasizes that the changes had no effect on the management of UBI. Because it would be difficult or impossible to restore the former ownership structure at this point due to the death of Mr. Jerry Green, UBI respectfully requests that the Commission grant its consent to this transfer of control of Licensee *nunc pro tunc*.
