**AMENDMENT**

Western Broadcasting, LS, LLC hereby amends the Assignee's Section of the application for Commission consent to the assignment of the licenses for KUNF(AM), Washington, Utah, and KREC(FM), Brian Head, Utah (FCC File Numbers BAL/BALH-20010314AAA-AAB) as indicated herein.


