TECHNICAL STATEMENT

This technical statement and attached exhibit were prepared on behalf of Cumulus Licensing LLC ("Cumulus").¹ Cumulus is requesting Special Temporary Authorization to use FM translator station W237DE, Channel 237D, Harrisburg, Pennsylvania to rebroadcast the programming of AM station WTCY, 1400 kHz, Harrisburg, Pennsylvania.

WTCY is a Class C AM station authorized to operate on 1400 kHz with a nominal power of 1.0 kilowatt, daytime and nighttime. Since the WTCY signal receives interference at night, use of W237DE as a translator for WTCY would improve service to an increased number of people. As noted on Exhibit #1, the translator's 60 dBu contour is wholly encompassed within the 2.0 mV/m daytime contour of WTCY and is well within the 40 kilometer (25 mile) radius from the WTCY transmitter site.





