INTERNATIONAL SPACING

With respect to international treaties, the proposed translator facility (#157329) is located within 125 km of the US/Mexican border and is subject to the US/Mexican Treaty and treated as a LPFM. The US/Mexican Treaty allows for such proposals as long as (1) protection is afforded to its Mexican facilities, in this case the Mexican FM Facility on Channel 244B at Nogales, Sonora, Mexico; (2) the protected contour (60 dBu) of the proposed facility does not extend more than 8.7 km in the direction of Mexico; and (3) the proposed interference contour does not exceed 32 km in the direction of Mexico (since the interference contour is based on a relationship with a facility and not a country, the worst case contour of 34 dBu was used). The following study, conducted pursuant to the procedures in the US/Mexican Treaty, demonstrates these protections can be provided to the Mexican allotment and Mexico with the limitation of the proposed translator facilities in the direction of the Mexican allotment and the country of Mexico.
