This letter is in reference to: (1) the above captioned minor change application, as amended on March 31, 2015, filed by Clear Channel Broadcasting Licenses, Inc. ("Clear Channel") to modify FM Radio Station WWBB(FM); (2) the March 9, 2015 Informal Objection filed by Greater Boston Radio, Inc. and Charles River Broadcasting Company ("Greater Boston"); and (3) the March 31, 2015 Motion to Dismiss Informal Objection filed by Clear Channel.

On March 9, 2015, Greater Boston filed an Informal Objection stating that Clear Channel's application, as originally filed, was in violation of 47 C.F.R. § 73.315. Specifically, Greater Boston argued that Clear Channel's proposed assignment site did not provide 70 dBu city coverage to 100% of the community of license as required by § 73.315. Clear Channel addressed Greater Boston's concerns in its March 31, 2015 amendment by changing the proposed assignment site. Furthermore, Clear Channel's amended assignment site complies with § 73.315.

In light of the above, the March 9, 2015 Informal Objection filed by Greater Boston Radio, Inc. and Charles River Broadcasting Company IS HEREBY DISMISSED AS MOOT. In addition, Application File No. BPH-20150213ACG, as amended on March 31, 2015, IS HEREBY GRANTED with conditions. The authorization is enclosed.
