DESCRIPTION OF TRANSACTION AND DOCUMENTS

The instant application is one of 12 concurrently filed applications seeking Commission consent to the transfer of control of the licenses of 13 full power commercial television stations, four Class A television stations, 21 low power and translator television stations, two AM and one FM radio stations, and related auxiliary and other facilities, from the shareholders of Fisher Communications, Inc., to Sinclair Television Group, Inc. (“STG”), an entity ultimately controlled by Sinclair Broadcast Group, Inc.

¹ As the Commission is aware, Fisher Broadcasting – Oregon TV, L.L.C. has entered into a Shared Services Agreement (“SSA”) with KMTR Television, LLC (“KMTR Television”), the approved assignee of KMTR(TV), Eugene, Oregon, FAC ID 35189 (the “Station”). See FCC File No. BALCDT-20121129BGX (granted April 24, 2013). The SSA will become effective upon closing of KMTR Television’s acquisition of the Station.
