

EXHIBIT 1

Purpose of Application

By this application and at the request of the Commission's staff, Sangre de Cristo Communications, Inc. ("SCC"), licensee of low power television station K30AA, Colorado Springs, Colorado, provides the Commission with corrected engineering data for K30AA on FCC Form 346. On June 22, 2001, SCC submitted an application on FCC Form 347 to correct certain technical data on the station's license. After reviewing that application, the Commission staff requested that SCC submit an underlying application for a construction permit on FCC Form 346.

The license for K30AA contains the following geographic coordinates (BLTT-198009111E):

38-44-42 North
104-51-39 West

The correct coordinates for the station's transmitter site, which were recently measured by the station's chief engineer with a GPS-based instrument, are as follows:

38-44-45 North
104-51-40 West

In addition, the FCC's TV Query Internet database incorrectly identifies K30AA's effective radiated power ("ERP") as 1.0 kilowatt. The correct ERP is 10.424 kilowatts. For the Commission's convenience, we are attaching hereto relevant pages from K30AA's 1982 license renewal application, which contains the proper ERP. See FCC File No. BRTT-19820225IC.

SCC respectfully requests that the Commission issue a construction permit and a covering license for K30AA reflecting the parameters described herein and in the application that SCC submitted on June 22, 2001.

The incorporated application or other form will thereafter, in its entirety, be open to the public.

F. This application shall be personally signed by the applicant, if the applicant is an individual; by one of the partners, if the applicant is a partnership; by an officer, if the applicant is a corporation; by a member who is an officer, if the applicant is an unincorporated association; by such duly elected or appointed officials as may be competent to do so under the laws of the applicable jurisdiction, if the applicant is an eligible government entity; or by the applicant's attorney in case of the applicant's physical disability or of his absence from the United States. The attorney shall, in the event he/she signs for the applicant, separately set forth the reason why the application is not signed by the applicant. In addition, if any matter is stated on the basis of the attorney's belief only (rather than knowledge), he/she shall separately set forth reasons for believing that such statements are true. Originals of Sections I and II must contain ORIGINAL SIGNATURES. Photo or other reproduced copies are not acceptable.
