Dear Counsel:

This is in reference to the request filed November 26, 2008, on behalf of WVKX-FM Radio, LLC ("WFR"). WFR requests extension of the special temporary authority ("STA") granted on May 29, 2008, to operate Station WXKO with temporary facilities.¹ In support of the request, WFR states that it continues to search for a new site for the station. WFR states that, upon successful location of property for a new site, it will file an application to relocate the transmitter.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WXKO may continue to operate with the following facilities:

Frequency	1150 KHz
Hours of operation	Unlimited

¹ WXKO is licensed for operation on 1150 kHz with 1 kilowatt daytime and 0.062 kilowatt nighttime, employing a nondirectional antenna (ND-2-U).

Operating power	Not to exceed 1 kW daytime, 0.062 kW nighttime
Antenna type	Long wire
Antenna efficiency	231 mV/m/km/kW
Overall height	9 meters

It will be necessary to further reduce power or cease operation if complaints of interference are received. WFR must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **December 30, 2009**.
