Licensee Town of Monroe, Connecticut (“Monroe”) is a local government entity. Monroe files this application to obtain Commission consent to new members of its Town Council. The selection of Monroe’s new Council took place pursuant to elections among the citizens of Monroe, Connecticut, and resignations and appointments to fill vacancies. The Council consists of nine voting members. The resulting transfer of control occurred gradually, over time, through routine changes in the Council’s membership. No consideration or thing of value is being given in exchange for the interests being transferred. All Council Members are U.S. citizens. Each Council Member has one vote.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the Council after 50% of the members of the Council have changed. The FCC last approved the Council in 2015, when it granted the Town’s Form 316 Application for Consent to Transfer of Control, BTCED-20141231BTZ, on January 27, 2015.
