

TECHNICAL STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS
CAPSTAR TX LIMITED PARTNERSHIP

This statement was prepared on behalf of Capstar TX Limited Partnership ("CTLP"), a licensee subsidiary of Clear Channel Communications, Inc. ("CCC"). CTLP proposes to modify WSKX (FM) York Center, Massachusetts. A multiple ownership analysis was prepared considering radio stations under present or proposed common ownership, time brokerage or joint sales.ⁱ

Arbitron Market Study

In this application, CTLP is making minor changes of Station WSKX (FM) York Center, Massachusetts. The community of license, York Center, Massachusetts, is in York County, which is part of the Portsmouth-Dover-Rochester, NH Arbitron Metro and thus WSKX (FM) is geographically located in this Arbitron Metro. WSKX (FM) is designated "home" to the Portsmouth-Dover-Rochester, NH Arbitron Metro; the number of stations owned by CCC in the Portsmouth-Dover-Rochester, NH Arbitron Metro is not changing by this application.

According to the FCC's local ownership "tiers," in a Metro reported by BIA as having 15 or more, and 29 and fewer commercial and noncommercial educational full-power radio stations, a party may have a cognizable interest in up to 6 commercial full-power radio stations, not more than 4 of which are in the same service(AM or FM) ⁱⁱ. This application complies with the multiple ownership rules because only 6 of 19 full-power radio stations (4 FM and 2 AM) will be attributable to CCC.
