Special Temporary Authorization

Dear Counsel:

This is in reference to the request filed March 17, 2008, on behalf of Jeri Lyn Broadcasting, Inc. ("JLB"). JLB seeks further extension of the special temporary authority ("STA") originally granted to former licensee Citicasters Licenses, Inc. on April 11, 2002, to operate Station KHTS with parameters at variance and/or reduced power while maintaining monitor points within licensed limits.¹ In support of the request, JLB provides a report of its progress toward restoring licensed operation. JLB states that its consulting engineer is in the process of designing a diplexed antenna system and preparing an application for construction permit.²

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

¹ KHTS is licensed for operation on 1220 kHz with 1 kilowatt daytime and 0.5 kilowatt nighttime, employing different directional antenna patterns daytime and nighttime (DA-2-U).


² However, to date no such application has been filed.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and is in the process of taking steps to resolve the matter; thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KHTS may continue to operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. It is anticipated that an application for construction permit will be filed prior to the expiration date below. JLB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **April 14, 2009**.
