**Duopoly Study
and
Demonstration of Compliance with Local Ownership Rules**

Attached are a table and maps demonstrating Visionary Related Entertainment LLC ("VRE") compliance with the Commission's multiple ownership rules.

The submitted application for the proposed minor change to KNUQ is permissible under the Commission's multiple ownership rules because of the following:

- 1) KNUQ is located in a non-Arbitron, unrated market (Maui) and is not a part of any other market in the Hawaiian Islands. The Island of Maui is geographically isolated from the other Hawaiian Islands. There are a total of Nineteen FM stations and Six AM stations in the Maui market, for a total of 25 stations in the market. Four VRE-owned primary signals (two AM and four FM) overlap the 70 dbu coverage area of this proposal. VRE is entitled to six stations, only four of which may be in one class, AM or FM.
- 2) None of the existing VRE operating stations in adjacent markets or Islands have an FM 70 dBu contour that overlap the 70 dBu contour of the proposed KNUQ facility on Ch. 280. This proposal has no VRE station overlap with adjacent markets, and is within the current limits set forth by the Commission's rules.
- 3) The modification of the KNUQ facility will not exceed the Commission's limit of four FM stations because it is the forth FM VRE station in the Maui market.
- 4) VRE has two currently operating AM stations in the Maui market, and they do overlap the proposed KNUQ 70 dBu contour. Therefore, VRE submits that there is overlap with four operating FM VRE facilities and two AM VRE facilities, but the number does not exceed the FCC limits on cross-ownership in an unrated market with at least 15 but not more than 29 stations (commercial and non-commercial), and is therefore in compliance with FCC duopoly rules.
- 5) Only those stations within 92 kilometers of the common overlap area will be considered as contributors to the market.

6) All data and information contained herein is true and accurate to our belief and knowledge. All data related to AM and FM facilities was derived from the FCC CDBS system.
