


**Multiple Ownership Compliance Study**  
**Cambridge/Byesville, Ohio**  
July 2013

This Multiple Ownership Compliance Study was conducted to determine if an entity can acquire WCMJ (FM) Cambridge, OH, WILE (AM) at Cambridge, OH and WILE-FM at Byesville, OH from AVC Communications, Inc. and be in compliance with §73.3555 of the Commission's Rules. Because Cambridge and Byesville, OH are not located in any BIA Metro, this study utilizes the Commission's Interim Contour-Overlap methodology.

The subject stations WCMJ (FM), WILE (AM) and WILE-FM are shown in Exhibit #1. All AM and FM services to the subject area are shown in Exhibit #2. Exhibit #3 is a tabulation of all services to the subject area. The combined contour maps show 13 services, including the 3 subject stations (1 AM and 2 FM). §73.3555(a)(1)(iv) states that a person or single entity (or entities under common control) may have a cognizable interest in licenses for AM or FM radio broadcast stations


*In a radio market with 14 or fewer full-power, commercial and noncommercial radio stations, not more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service (AM or FM); provided, however, that no person or single entity (or entities under common control) may have a cognizable interest in more than 50% of the full-power, commercial and noncommercial radio stations in such market unless the combination of stations comprises not more than one AM and one FM station.*

Based on these findings, it is believed that the ownership of these three stations in this market is in compliance with §73.3555 of the Commission's Rules. All statements contained herein are thought to be accurate and correct to the knowledge of the undersigned.


