
On behalf Townsquare Media Shreveport License, LLC, the licensee of AM broadcast stations KEEL and KWKH, this is to request a waiver, pursuant to the procedures set forth in September 13, 2011 Public Notice DA 11-1535, of Section 73.1560(a) of the Commission's rules to permit the stations to utilize Modulation Dependent Carrier Level ("MDCL") control technologies.

Both KEEL and KWKH are currently operating in normal modulation without hybrid digital mode. With MDCL operation, both stations' signals will continue comply with spectral emissions mask requirements in Section 73.44 of the Commission's rules. Both stations' transmitters will achieve full licensed power at +10dbm, or when the MDCL is temporarily disabled.

The transmitter for KEEL is proposed to utilize Harris AMC MDCL modulation kit HAR3DXLPAMC-ACCFLD, as installed by the factory technician. The transmitter for KWKH is proposed to utilize Harris AMC MDCL modulation kit HARDXLPAMC-ACCFLD, also as installed by the factory technician. The stations will retain the ability to bypass to normal modulation for power and field readings, as needed.

An executed Anti-Drug Abuse Certification is attached. Please let me know if you need any additional information or have any questions.
