

SECOND SUPPLEMENTAL INTERFERENCE COMPLAINT

Bott Communications, Inc. ("Bott"), licensee of full-power FM broadcast station, KCIV, Mount Bullion, California (Facility ID No. 6504) (Channel 260/99.9 MHz) ("KCIV"), by its undersigned counsel and pursuant to Section 74.1203 of the Commission's rules,¹ hereby submits this Second Supplement to its original interference complaint ("Interference Complaint"), dated July 18, 2018 (as supplemented September 17, 2018), against FM translator, K259CF, South Fresno, California (Facility ID No. 144742) ("K259CF"), licensed to Gary M. Cocola, with additional listener complaints.

Since the filing of its original Interference Complaint and its Reply and Supplement to Interference Complaint, Mr. Cocola's operation of K259CF on KCIV's first-adjacent channel (i.e., Channel 259/99.7 MHz) continues to cause interference to the regular listeners' reception of KCIV in and around Fresno and Clovis, California. Attached hereto are the additional complaints of 20

KCIV listeners (**Attachment A**),² as well as an updated map depicting the locations of the listener complainants (**Attachment B**).³

In light of the continuing and amassing complaints, covering specific locations as well as ranging locations, it is clear that the interference to KCIV is ongoing. As shown previously, the FCC's *current* rules expressly provide that an FM translator station "will not be permitted to *continue to operate* if it causes any actual interference to . . . the direct reception by the public of the off-the-air signals of *any* authorized broadcast station . . ."⁴ Very significant interference has been established – yet three months have passed and Mr. Cocola has been allowed to continue to operate the offending FM translator to the detriment of KCIV's loyal listeners. The FCC must enforce its rules. Bott requests that the Commission order K259CF to cease operations immediately.



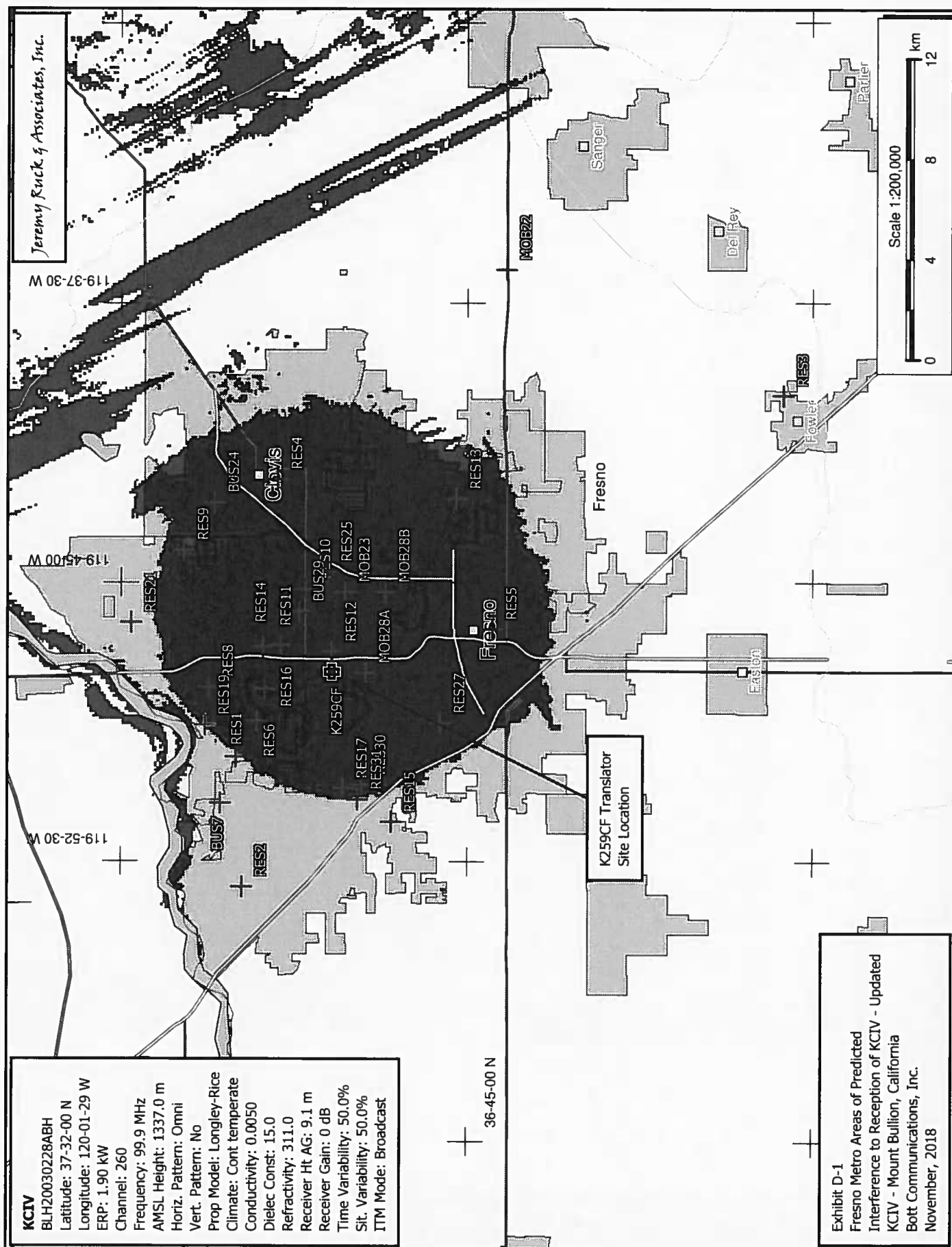

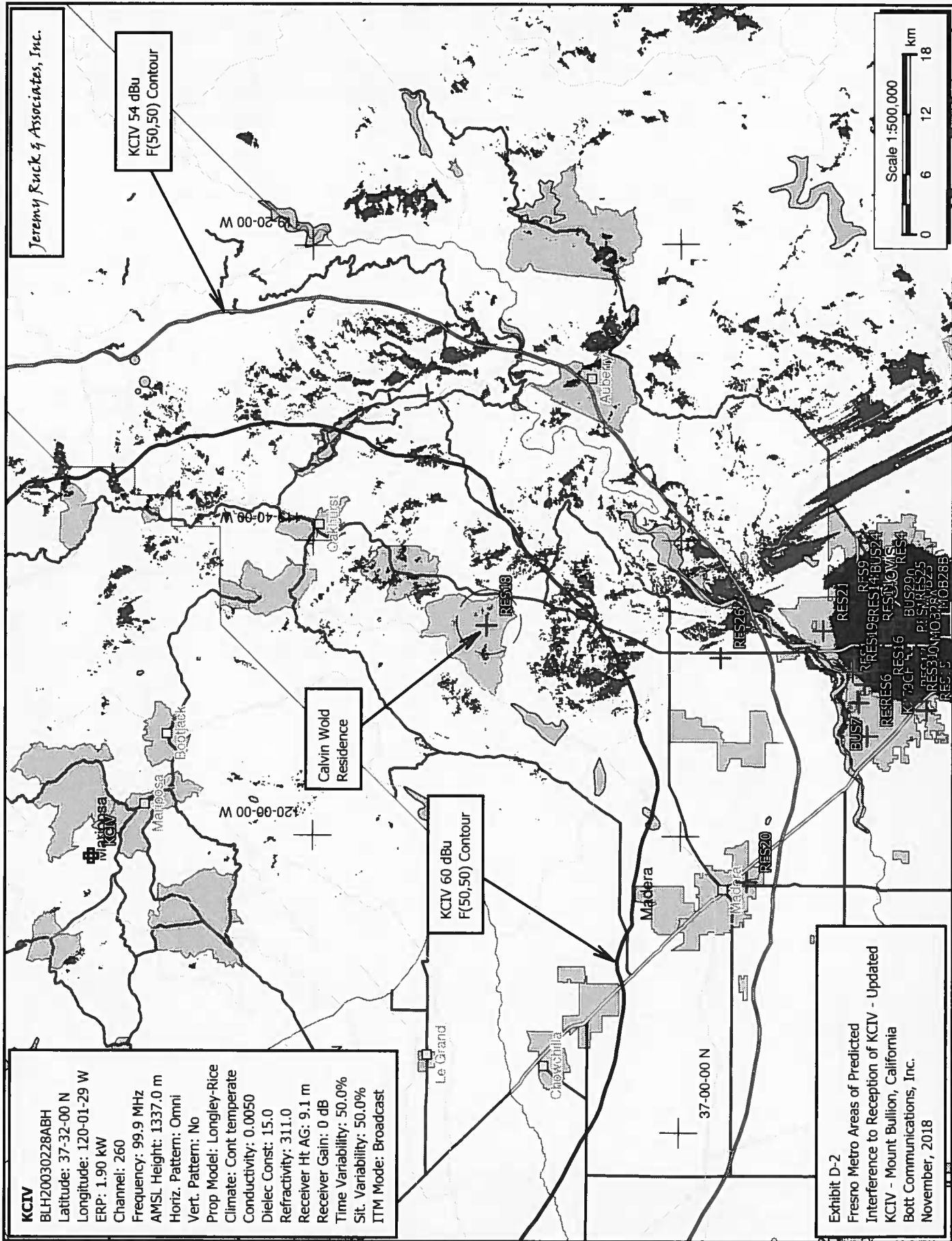
