A de minimus interference analysis was performed pursuant to Appendix B of the FCC Sixth Report and Order in MM Docket No. 87-268 and FCC OET Bulletin No. 69. The software used to perform the analysis is the same as that being used by the FCC for application processing and, therefore, should yield the same results. The results of that analysis indicate that the proposed facility meets the FCC's de minimus interference criteria towards all other DTV allotments as well as all authorized DTV and analog stations as noted in the analysis summary provided below.
