In evaluating the proposed Digital Flash Cut for K26HS Facility ID 130787, an outgoing interference study was executed on the proposed design, in the attached application, using the OET-69 Longley Rice methodology. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference, there was zero percent interference present. This was found in each case when rounded to the nearest whole percent.
