

## EXHIBIT 16

### OTHER AUTHORIZATIONS

The stock of Pegasus Satellite Communications, Inc. (“PSC”), the proposed transferee, presently is held by the PSC Liquidating Trust (“PSC Trust”). The PSC Trust, in turn, is controlled by Ocean Ridge Capital Advisors, LLC (“Ocean Ridge”), the liquidating trustee. The managing member of Ocean Ridge is Bradley E. Scher.

Bradley E. Scher, through Ocean Ridge and the PSC Trust, has ultimate control of the licensees and permittees which hold Federal Communications Commission (“FCC”) authorizations for the following full- and low-power television broadcast stations:

Pegasus Broadcast Television, Inc., ultimately controlled by Bradley E. Scher, through Ocean Ridge and The PSC Trust, has applications pending for construction permits for new low-power television translator stations in Reddick, Florida, and Tylertown, Mississippi. *See* FCC File Nos.
