

## **OWNERSHIP STRUCTURE AND INTERESTS**

### Overview

Univision Communications Inc. ("UCI") through its principal subsidiaries, Univision Television Group, Inc. ("UTGI") and Telefutera Television Group, Inc. ("TTGI"), is the ultimate parent of the licensees of television broadcast stations. UCI is also a shareholder of Entravision Communications Corporation ("Entravision") which directly or indirectly holds additional television and radio broadcast station licenses.<sup>1</sup> UCI's ownership structure and direct broadcast interests are described in Section I below. UCI's interests held through UTGI are described in Section II below. UCI's interests held through Telefutera are described in Section III below. UCI's ownership interests held through Entravision are described in Section IV below.

#### I. Univision Communications Inc.

UCI is a publicly-traded company, and no single person or entity holds 33% or more of the debt/equity of the company. A. Jerrold Perenchio is the single majority shareholder, with a 66.32% voting interest in UCI, by virtue of the fact that his Class P common stock is entitled to 10 votes per share so long as he continues to own at least 30% of the shares he held on October 2, 1996.

Grupo Televisa, S.A. and Venevision Investments LLC are shareholders of UCI which are each represented by a director on the Board of Directors and which are controlled by non-U.S. citizens. In addition, each entity holds non-voting stock and certain warrants which would allow it to increase its holdings to the extent that it is lawful for such a foreign entity to do so. In the past, the Commission has routinely approved interests such as these held by foreign entities. See Univision Holdings, Inc., 7 FCC Rcd 6672, 6673-74 (1992); FCC File Nos. BTCCT-9606281ID through BTCCT-960628IN and BTCCT-960628IP through BTCCT-960628IV.

Certain officers and directors of UCI also hold positions as the officers and directors of the broadcast subsidiaries discussed herein. In addition, John G. Perenchio is the son of A. Jerrold Perenchio.

<sup>1</sup> As noted below, applications are pending before the FCC in connection with the transfer of control of Hispanic Broadcasting Corporation ("HBC") to UCI. Upon consummation of the transactions proposed therein, UCI will not hold an attributable interest in Entravision. However, because the applications remain pending, information regarding Entravision is provided herein.

Finally, on July 23, 2002, an application was filed with the FCC seeking its consent to the transfer of control of Hispanic Broadcasting Corporation to UCI. See FCC File No. BAL-20020723ABL, et al.

II. Univision Television Group, Inc.

UTGI is wholly owned by PTI Holdings, Inc. ("PTI"), which, in turn, is wholly owned by UCI. UTGI is the controlling general partner and PTI is the non-controlling general partner of the following licensee partnerships, which are the licensees of the indicated broadcast stations:

In addition, UTGI is the sole shareholder of Univision of Atlanta Inc. and Univision of New Jersey Inc., and is the sole member of Univision Cleveland LLC. Univision of Atlanta Inc. is the sole member of Univision Atlanta LLC, the licensee of WUVG(TV), Athens, Georgia (FIN: 48813). Univision of New Jersey Inc. is the sole member of Univision New York LLC, the licensee of WFTY(TV), Smithtown, New York (FIN: 60553) and WFUT(TV), Newark, New Jersey (FIN: 60555). Univision of New Jersey Inc. is also the sole member of Univision Philadelphia LLC, the licensee of WUVP(TV), Vineland, New Jersey (FIN: 60560). Univision Cleveland LLC is the licensee of WQHS-TV, Cleveland, Ohio (FIN: 60556).

In addition, UTGI owns a 1% partnership interest in Capital Broadcasting Partners and is the sole shareholder of Univision of Raleigh, Inc., the 99% partner in Capital Broadcasting Partners. Capital Broadcasting Partners is the licensee of WUVC(TV), Fayetteville, North Carolina (FIN: 16517).

Finally, UTGI is also the applicant for assignment of permit of KXGR(TV), Green Valley, Arizona (FIN: 63927) (FCC File No. BAPCT-20020109AAR) and for a new television station on Channel 52 at Blanco, Texas.

III. Telefutura Television Group, Inc.

TTGI, a Delaware corporation, is 100% owned by UCI. TTGI is the licensee of KTFQ(TV), Albuquerque, New Mexico (FIN: 57220) and the proposed assignee of KFTL(TV), Stockton, California (FIN: 20871) (FCC File No. BALCT-20030429AAK). TTGI is the sole member of each of the following limited liability companies, which are the licensees of the indicated broadcast stations:

IV. Entravision

UCI holds 21,983,392 Class C and 14,942,931 Class A shares of Entravision Communications Corporation ("Entravision"), which represent approximately 29.38% of the outstanding stock of that company (9.85% voting interest). Entravision, through various subsidiaries, owns and operates multiple radio and television stations. Specifically, Entravision is the parent of Entravision Holdings, LLC ("EHL"), the licensee or permittee of the following stations:

EHL is the applicant for new low power television station on Channel 39 at Fort Collins, Colorado (FIN: 125874)(File No. BNPTT-20000822AAS).

On June 23, 2003, the Commission granted a construction permit to EHL for new station K54IK, FT Collins, Colorado (FIN:126176) to replace current STA operation of station K03EM, Glen Haven, Colorado, under temporary call sign K43FN, Ft Collins, Colorado.

On July 8, 2003, the Commission granted an application for consent to assignment of a construction permit for station K31FC, San Diego, California (FIN: 13022) from Community Service Television Company to EHL (File No. BAPTTL-20030529AMB).

Entravision Midland Holdings, LLC, an affiliate of Entravision, is an applicant for new low power television station construction permits for Fort Stockton, Texas (FIN: 125862), Pecos, Texas (FIN: 125859), and Big Springs, Texas (FIN: 125865).

Entravision provides programming to Desert West Air Ranchers Corporation, the licensee of KZNO(FM), Nogales, Arizona (FIN: 36023), pursuant to a Time Brokerage Agreement.
