Dear Licensee:

NRG License Sub, LLC. is hereby notified of the modification of its license for KQKQ-FM, Council Bluffs, IA, to specify operation on Channel 253C0.

On January 18, 2007, Alpha Media Licensee LLC. ("AML"), licensee of a station in Burlingame, KS, filed a minor change construction permit application. AML's application proposed that KQKQ-FM's license be modified to specify Class C0 in lieu of Class C in accordance with the procedures set forth in Note 4 of 47 C.F.R. Section 73.3573.¹ Accordingly, by staff letter dated December 7, 2015, KQKQ-FM was directed to show cause why its license should not be modified to specify Channel 253C0 in lieu of Channel 253C. The letter stated that failure to respond to this letter within thirty days will result in the automatic downgrade of KQKQ-FM. As of the date of this letter, KQKQ-FM has failed to file a response to the December 7, 2015 letter, and thus, has consented to the downgrade.

Accordingly, pursuant to the authority found in Sections 4(i), 5(c)(1), 303, and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, as amended, IT IS ORDERED, that effective the date of this letter, the FM assignment IS MODIFIED, as follows:
