

SUPPLEMENT TO MULTIPLE OWNERSHIP EXHIBIT
Common ownership of WQNC Harrisburg NC, WPZS Indian Trail NC,
WNOW-FM Gaffney SC and WZZQ Gaffney SC

This exhibit is part of a Minor Amendment to a pending application filed by WQNC, (File BPH-20120726AAH), and part of a Minor Amendment to a pending application filed by WNOW-FM and WZZQ (AM), (File BTCH - 20120806ABF).

WQNC filed a Form 301 Application for Construction Permit to change the station class of WQNC from Class A to Class C3. WNOW-FM and WZZQ(AM) filed a Form 315 Application for Consent to Transfer Control that will result in common ownership of WQNC, WPZS, WNOW-FM and WZZQ (AM).

The pending WQNC application proposes a 70 dBu coverage contour that increases the area of a overlap created radio market (Charlotte Overlap), when Interim Contour-overlap Methodology is used. The existing broadcast service in the Charlotte Overlap is pertinent to the multiple ownership portion of the pending WNOW-FM/WZZQ (AM) application, and the pending WQNC application. The increased overlap area created by the pending WQNC application is addressed in this exhibit.

Post-transaction, Radio One, Inc. will have an attributable interest in WQNC, WPZS, WNOW-FM and WZZQ (AM). The subject Arbitron radio Metro market is Charlotte-Gastonia-Rock Hill. The four radio stations broadcast in or near this Metro market, and multiple ownership compliance was studied by using the Arbitron/BIA Metro method and Interim Contour-overlap Methodology.

As described in the pending WNOW-FM/ WZZQ (AM) application:

1. At least 15 full power FM stations provide a 70 dBu coverage contour that intersects the 70 dBu coverage contours forming the Charlotte Overlap. Therefore, the Charlotte Overlap radio market is served by at least 15 stations, and the proposed common ownership of four stations in this radio market is in compliance with FCC rules and policy.
2. Charlotte-Gastonia-Rock Hill is an Arbitron radio Metro market, and BIA reports 70 radio stations are designated "home" to the market. The proposed common ownership of four radio stations is permitted in this radio market.
3. WNOW-FM and WZZQ (AM) are licensed to a community that is located in a county outside the Charlotte Arbitron radio Metro market. WNOW-FM and WZZQ (AM) form a overlap created radio market (Gaffney Overlap) that is served by at least nine full power FM stations. As an original AM/FM combo licensed to Gaffney SC, and numerically less than 50 percent of the stations providing service to the Gaffney Overlap, the proposed common ownership of WNOW-FM and WZZQ (AM) is permitted.

With regard to the pending WQNC application:

1. The proposed WQNC Class C3 facility increases the size of the Charlotte Overlap. The larger Charlotte Overlap receives service from at least 15 full power FM stations, as shown in Figure One. In addition to the FM stations, the area is served by a number of AM stations. The proposed common ownership of four stations in this larger overlap radio market is in compliance with FCC rules and policy.
2. The WQNC proposal does not increase the number of radio stations commonly owned by Radio One Inc. that are “home” to the Charlotte Arbitron radio Metro market. The proposed common ownership of four radio stations is permitted in this market.

Description of figures:

Figure One shows the Charlotte Gastonia Rock Hill Arbitron radio market, and the location of the community of license for each of the pertinent stations.

Figure Two shows 70 dBu contours of the stations, and the radio markets created where the contours overlap.

Figure Three shows the Charlotte Overlap radio market created by the licensed WQNC 70 dbu contour and the proposed WQNC 70 dBu contour, and the 70 dBu contours of WPZS and WNOW-FM.

Figure Four shows contours of full power FM stations providing 70 dBu coverage to the Charlotte Overlap radio market.

Figure Five shows the Gaffney Overlap radio market created by the WNOW-FM 70 dBu contour and the WZZQ 5 mV/m contour.

Figure Six shows contours of full power FM stations providing 70 dBu coverage to the Gaffney Overlap radio market.

Summary:

Post-transaction, Radio One Inc. will have an attributable interest in four radio stations in or near the Charlotte-Gastonia-Rock Hill Arbitron Metro. By employing both the Arbitron/BIA radio Metro market method and Interim Contour-overlap Methodology, the pending WQNC Application for Construction Permit and the pending Application for Consent to Transfer Control of WNOW-FM and WZZQ (AM) each propose common ownership that is in compliance with FCC rules and policy.

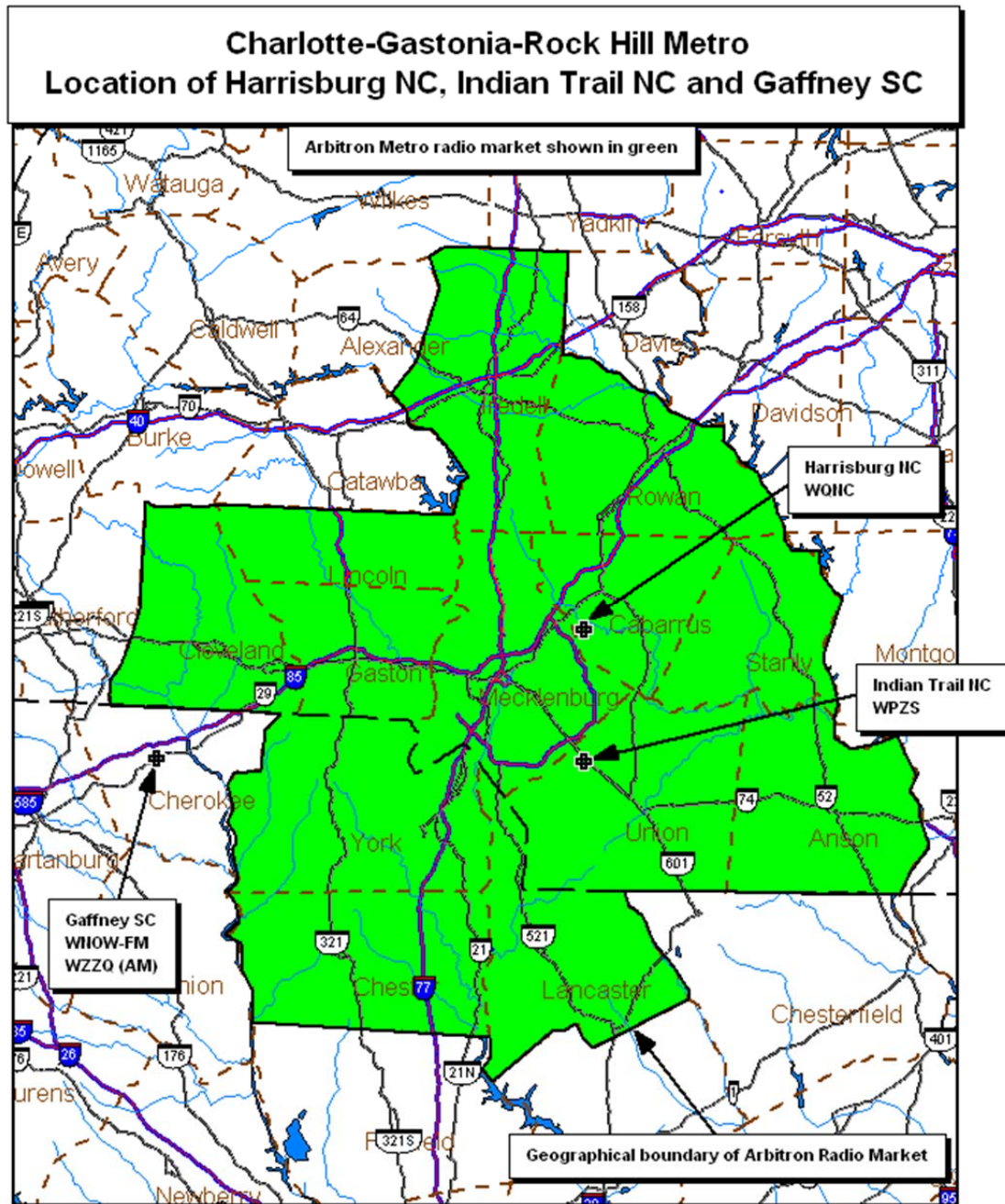

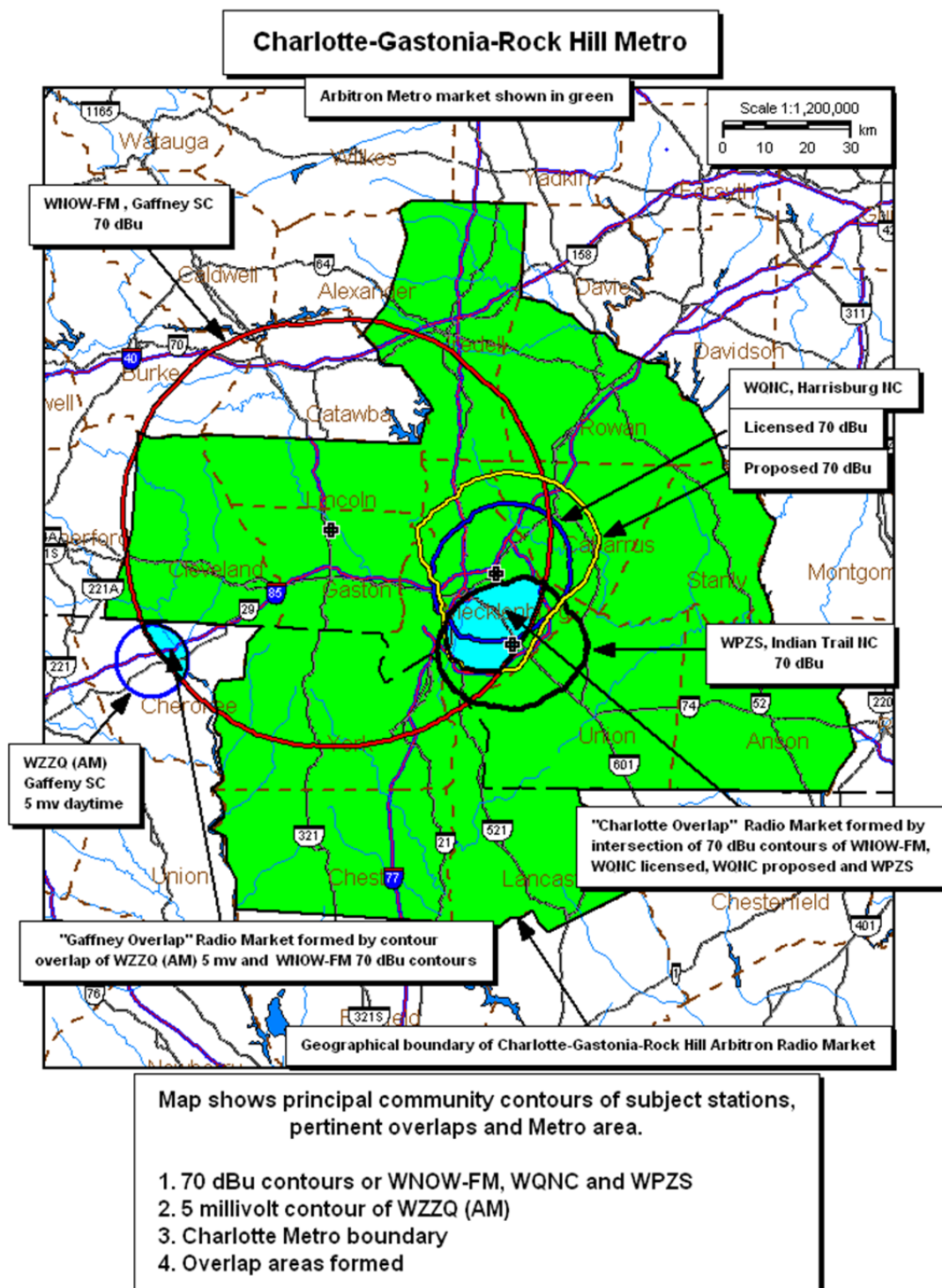
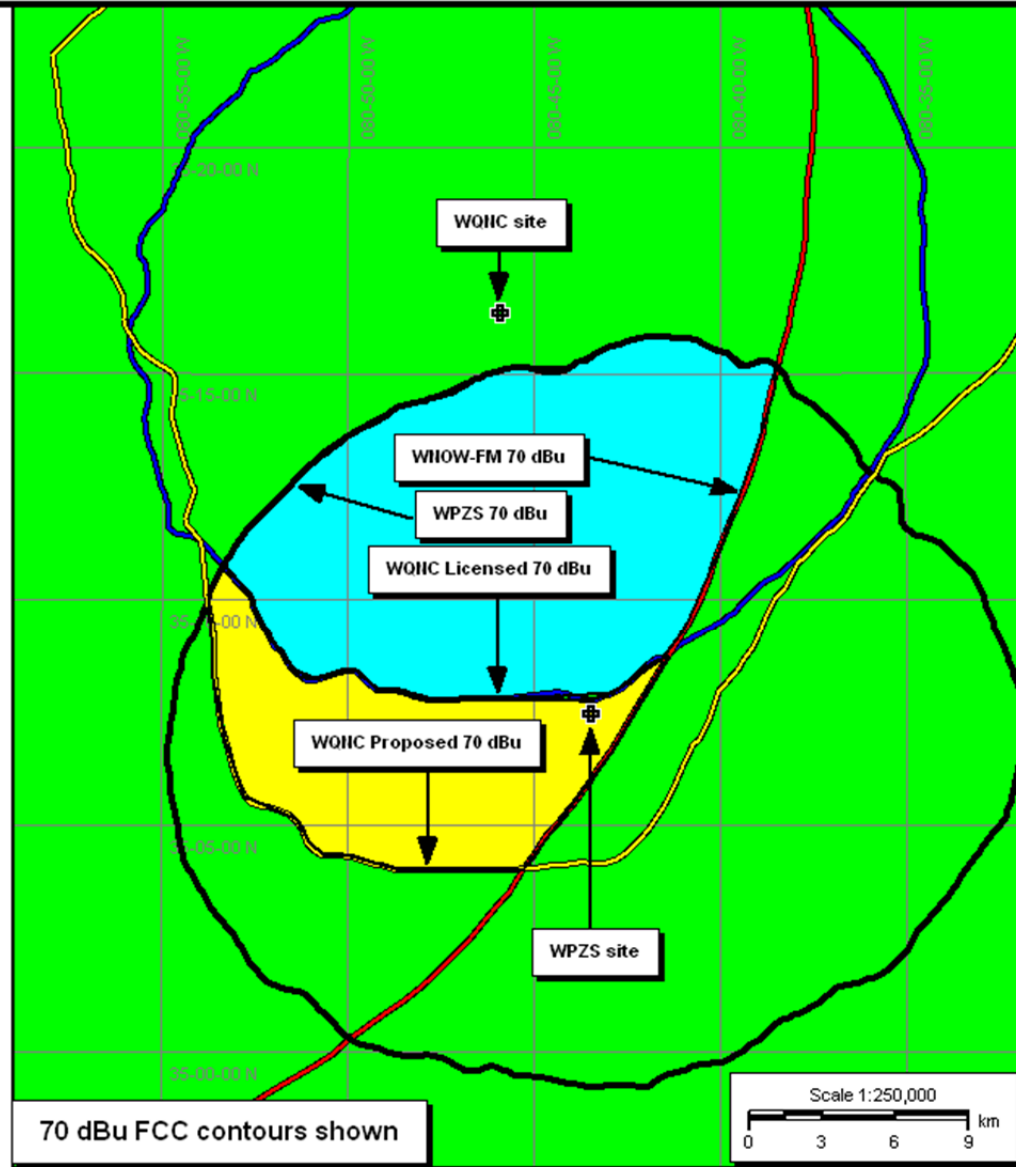

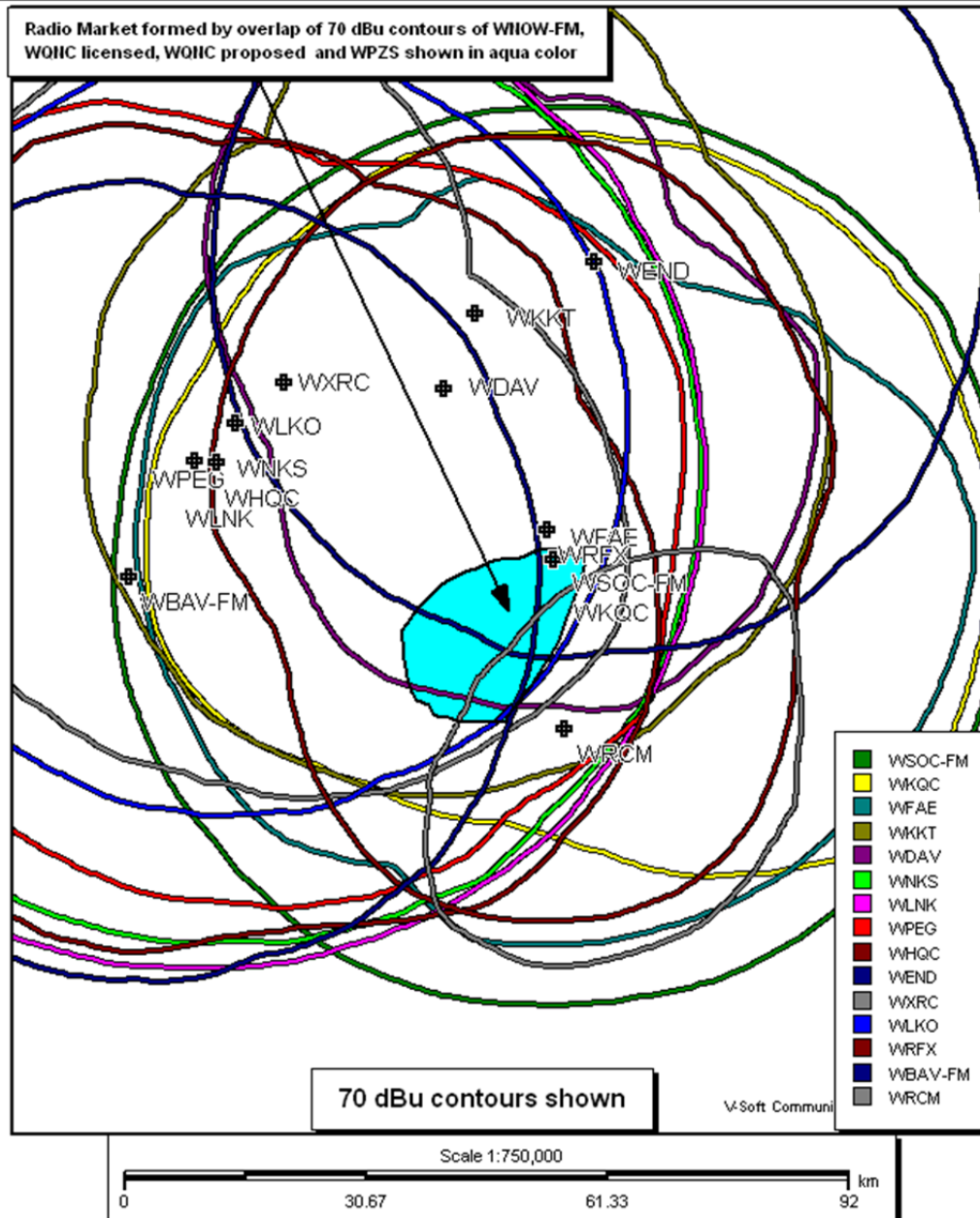

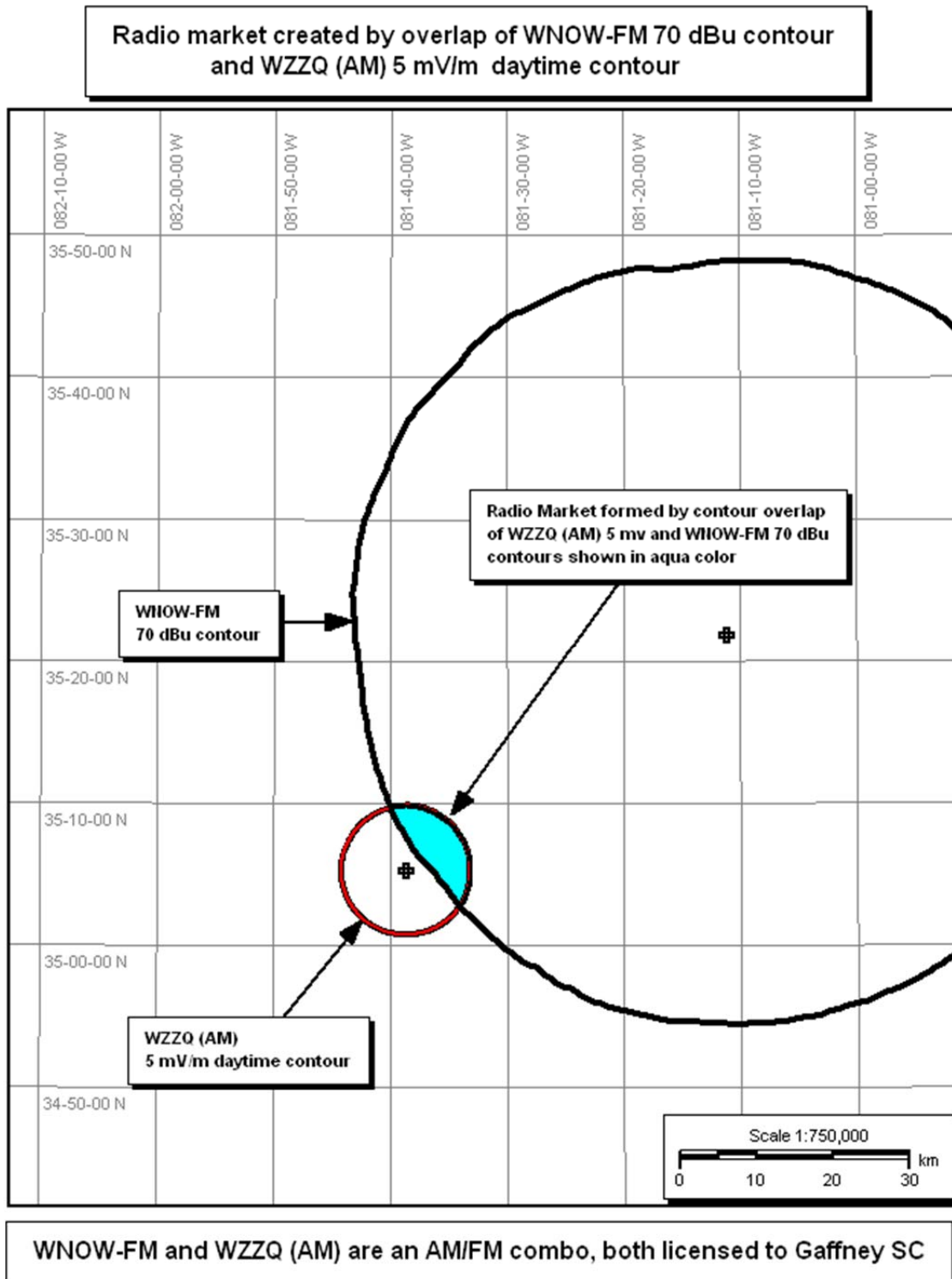
