EXPLANATION OF COMPLIANCE WITH MULTIPLE OWNERSHIP RULE

MR. FRED EYCHANER IS THE 100% OWNER, THROUGH VARIOUS ENTITIES, OF 9 RADIO STATIONS: FIVE AM STATIONS — WNDZ(AM), PORTAGE, INDIANA (PORTER COUNTY); WCPT(AM), CRYSTAL LAKE, ILLINOIS (MCHENRY COUNTY); WCFJ(AM), CHICAGO HEIGHTS, ILLINOIS (COOK COUNTY); WSBC(AM), CHICAGO, ILLINOIS (COOK COUNTY); WAIT(AM), CHICAGO, ILLINOIS (COOK COUNTY) — AND FOUR FM STATIONS — WDEK(FM), DEKALB, ILLINOIS (DEKALB COUNTY); WKIF(FM), KANKAKEE, ILLINOIS (KANKAKEE COUNTY); WKIE(FM), ARLINGTON HEIGHTS, ILLINOIS (COOK COUNTY); AND WRZA(FM), PARK FOREST, ILLINOIS (WILL COUNTY). AS DEMONSTRATED BELOW, MR. EYCHANER’S OWNERSHIP OF THESE STATIONS IS FULLY COMPLIANT WITH THE COMMISSION’S MULTIPLE OWNERSHIP RULES.

UNDER SECTION 73.5555(A)(1)(I) OF THE FCC’S RULES, IN A MARKET WITH 45 OR MORE COMMERCIAL AND NONCOMMERCIAL FULL-POWER STATIONS, A PARTY MAY HAVE A COGNIZABLE INTEREST IN UP TO 8 COMMERCIAL STATIONS, NOT MORE THAN 5 OF WHICH MAY BE IN THE SAME SERVICE.

THE ATTACHED BIA GEOGRAPHIC MARKET REPORT SHOWS THAT THERE ARE 129 STATIONS PRESENTLY SERVING THE CHICAGO RADIO MARKET. THE ARBITRON METRO MARKET DEFINITION FOR CHICAGO, WHICH IS ALSO ATTACHED HERETO, INCLUDES THE COUNTIES OF: COOK, DUPAGE, KANE, KENDALL, LAKE, WILL, PORTER, GRUNDY, MCHENRY, AND KENOSHA.

ARBITRON SHOWING

TWO OF THE FOUR FM STATIONS (WDEK(FM) AND WKIF(FM)) ARE IN COUNTIES THAT ARE NOT PART OF THE CHICAGO ARBITRON METRO MARKET, INDEED THEY ARE NOT CONSIDERED TO BE PART OF ANY ARBITRON METRO MARKET. WDEK(FM), HOWEVER, WAS PART OF THE CHICAGO ARBITRON METRO MARKET UNTIL JANUARY 20, 2005. THUS, UNDER THE COMMISSION’S OWNERSHIP RULES, IT WILL CONTINUE TO BE TREATED, FOR OWNERSHIP COMPLIANCE PURPOSES, AS PART OF THE CHICAGO MARKET UNTIL JANUARY 20, 2007.

THEREFORE WDEK(FM) IS COUNTED TOWARD THE 8 STATION CAP, BUT WKIF(FM) IS NOT. CONSEQUENTLY, MR. EYCHANER HAS AN ATTRIBUTABLE INTEREST IN 8 STATIONS (5 AM AND 3 FM) LOCATED IN THE CHICAGO ARBITRON METRO MARKET, AND THEREFORE THIS APPLICATION COMPLIES WITH THE MULTIPLE OWNERSHIP RULES.

CONTOUR OVERLAP SHOWING

FURTHERMORE, THE ATTACHED ENGINEERING OWNERSHIP STUDY DEMONSTRATES THAT THE PRINCIPAL COMMUNITY CONTOUR OVERLAP OF THE 9 STATIONS DOES NOT CREATE A MARKET WITH MORE THAN 8 STATIONS TOTAL OR WITH MORE THAN 5 STATIONS IN THE SAME SERVICE.

Engineering Statement

This Engineering Exhibit has been prepared on behalf of Fred Eychaner (herein “Eychaner”), who is the sole shareholder of individual corporate entities, which hold licenses for five AM stations and four FM station in the Chicago, Illinois area. These stations are listed on Figure 1. Newsweb intends to improve the facilities of AM station WAIT by the addition of a nighttime directional operation. The proposed WAIT nighttime coverage is completely within the daytime coverage of the station. As the stations shown in Figure 1 have overlapping principal community contours, this ownership study has been prepared.

Figure 2 is a map showing the principal community contours of the Eychaner stations. As will be noted, the principal community contour of FM station WDEK DeKalb, IL does not overlap the principal community contours of any of the other stations, so it is excluded from the ownership study.

The overlap of the principal community contours of stations WCPT, WKIE, WSBC and WAIT comprise Market No. 1. The principal community contours of stations WSBC, WAIT and WNDZ comprise Market No. 2. Market No. 3 is made up of the contours of WAIT, WCFJ and WRZA. The contours of WKIF and WRZA make up market No. 4. Figure 3 is a map showing the contours involved in the ownership study along with the principal community contours of any other intersecting commercial AM or FM stations.

The number of stations in a market is determined by counting the commercial stations having principal community contours, which overlap or intersect the principal community contours defining the radio market. The number of stations in each is listed below.

The number of stations available in each market greatly exceeds the ownership requirements of 47 CFR 73.3555.

The stations providing a principal community contour to the four markets are listed in Figure 4. Due to the extensive number of stations involved, identification of each contour shown on Figure 3 was not attempted.

Geographic coordinates for the transmitter sites of stations shown herein were obtained from the FCC computer database. The 5 mV/m contours for AM stations were determined from data contained in the Commission's database and the appropriate Ground Wave Field Strength versus Distance Graphs of 47 CFR 73.184. Estimated ground conductivity is from the Commission's conductivity map, Figure M-3. Available measured conductivities are not expected to materially change the location of any of the AM station contours.

Distances to FM contours were determined based on the method of 47 CFR 73.313, utilizing 36 radials. FM station effective radiated power and antenna height above average terrain were taken from the FCC computer database.






OWNERSHIP STUDY PRINCIPAL COMMUNITY CONTOURS


