

## INTERFERENCE ACCEPTANCE AGREEMENT

This Interference Acceptance Agreement ("Agreement") is entered into as of 12/18, 2009 by and between Detroit Free Press, Inc., ("DFP"), licensee of WUSA-TV, Washington, D.C., and WGAL Hearst Television, Inc. ("WGAL"), licensee of WGAL-TV, Lancaster, Pennsylvania.

1. WUSA is authorized by the Federal Communications Commission ("FCC") to operate on post-transition digital Channel 9 in Washington, D.C. WGAL is authorized by the FCC to operate on post-transition digital Channel 8 in Lancaster, Pennsylvania.

2. Due to loss of service issues in the northern portion of its DMA, WUSA desires to perform tests and take associated measurements to determine the effect of operation at an increased power level of 52kW ERP, compared to its authorized 12.6 kW ERP, using its existing non-directional antenna.

3. WUSA intends to file an application with the FCC for an experimental Special Temporary Authorization ("STA") covering a six (6)-month period ("STA Period") to conduct such tests at 52kW ERP for extended periods of time within the STA Period.

4. WUSA shall have the right to extend the STA for an additional six (6)-month period beyond the initial STA Period, as necessary, to ensure accurate and thorough test results.

5. WUSA's power increase is predicted to cause 2.7 percent new interference to WGAL-TV. WGAL hereby agrees to accept this predicted interference from WUSA during the STA Period and any extension thereof.

6. WUSA will notify WGAL prior to all testing and measurement periods, coordinate its testing schedule with WGAL, and afford WGAL representatives the opportunity to participate in and observe any and all tests and measurements designed to determine the extent of actual interference to WGAL.

7. While it is highly unlikely that these tests will cause reception problems to WGAL viewers, if it is noted and verified that loss of reception, of the WGAL signal, is a direct result of these tests, then WUSA agrees to return to their currently authorized power until such time as the reception problems can be resolved.

8. Inasmuch as WGAL, who also has suffered from loss of service, has granted this request from WUSA for tests using higher ERP levels than are currently authorized, it is assumed that approval would be granted to WGAL by WUSA should WGAL desire to run similar tests with higher ERP levels than are currently authorized, using its existing non-directional antenna.

9. The parties hereby agree that this Agreement may be filed with the FCC to aid in securing the experimental STA and any extension thereof.

10. Except for the mutual agreement set forth in this Agreement, no further consideration, financial or otherwise is required or promised by either party.


