Notice of Main Studio Relocation**

Dear Ms. Dortch:

Townsquare Media Monmouth-Ocean License, LLC ("Townsquare"), the licensee of AM broadcast station WADB and FM broadcast station WJLK, by its attorneys and pursuant to Section 73.1125(d) of the Commission's rules, hereby notifies the Commission that the stations' main studio has been temporarily relocated to 1015 Atlantic City Blvd., Bayville, NJ 08721.

Townsquare was forced to move the stations' main studio location on very short notice after its landlord unexpectedly refused to renew the lease for the two stations' prior main studio location. The present location is approximately 25.8 miles from the post office in Asbury Park, the stations' community of license. Telephone calls between Asbury Park and the present location are considered local.

This new location is intended to serve only as a temporary solution while the stations' new main studio at 8 Robbins Street, Toms River, NJ is being constructed. Townsquare had intended for the stations' main studio to remain at the prior location until this construction was complete, but the present circumstances necessitated the unplanned move to the current location.

The stations' new main studio location in Toms River will comply fully with the Commission's main studio requirements. Construction of the new facility is progressing on schedule. Architectural and mechanical aspects of construction are substantially complete and Townsquare is now awaiting a local permit for authorization to begin construction on the interior of the building. Townsquare anticipates being able to move the stations' main studio to the new location within approximately 90 days.

Townsquare respectfully submits that, because the present location is only slightly more than 25 miles from the post office in the stations' community of license and is only an interim arrangement, the stations' current main studio location falls within Section 73.1225(b)(2) of the Commission's rules, which allows for location of an AM or FM station's main studio other than as specifically described the Commission's rules "when good cause exists...and when doing so would be consistent with the operation of the station in the public interest." In this case, the interim main studio location allows the stations to continue providing uninterrupted service during the transition to the new main studio location. Townsquare will notify the Commission immediately when it is able to move the stations' main studios to that location.

The licensee's mailing address remains unchanged.
