I, GEORGE S. WALKER III, a resident of the State of Georgia, do hereby declare and publish this as and for my Last Will and Testament, hereby revoking any and all prior wills and codicils made by me.

ARTICLE I

FAMILY MEMBERS

For purposes of this Will, all references to my "wife" shall refer to ANGELA B. WALKER, and all references to the term "child" or "children" shall be deemed to include my present children, RHETT ALAN WALKER, CASEY BRYANT WALKER, BRANNON KEATS WALKER and GEORGE ERIC WALKER. All references to the term "descendant" or "descendants" shall be deemed to include my child or children and any natural or legally adopted child of my child or children and their descendants.

ARTICLE II

APPOINTMENT OF EXECUTOR AND TRUSTEE

I hereby appoint my sons, RHETT ALAN WALKER and CASEY BRYANT WALKER, as my Co-Executors of this my Last Will and Testament and as Co-Trustees of all trusts created herein. In the event that my son RHETT ALAN WALKER, shall fail to qualify or cease for any reason, to serve as Co-Executor or Co-Trustee, or both, hereunder, then my son, GEORGE ERIC WALKER, shall serve as Successor-Co-Executor or Successor-Co-Trustee, or both, in his place. In the event that my son, CASEY BRYANT WALKER, shall fail to qualify or cease, for any reason, to serve as Co-Executor or Co-Trustee, or both, hereunder, then my son, BRANNON KEATS WALKER, shall serve as Successor-Co-Executor or Successor-Co-Trustee, or both, in his place.
