Notice of Tolling Event and Request for Tolling

Dear Ms. Dortch:

Pursuant to Section 73.3598 of the Commission's Rules, and on behalf of Zwerling Broadcasting System Ltd. ("ZBS"), the permittee of unbuilt FM Translator Station K234CS at Carmel Valley, California, we hereby submit in triplicate this request for the tolling of the authorized period of construction for underlying Construction Permit BMPFT-20160104AMU (hereinafter referred to as "K234CS Construction Permit"). A copy of the K234CS Construction Permit is attached.

ZBS consummated the purchase of the K234CS Construction Permit on August 12, 2016 pursuant to assignment application BAPFT-20160523ABJ. The long term goal for acquiring K234CS was to subsequently move the translator facility to the Santa Cruz, California area to serve as a fill-in for Radio Station KSCO-AM. KSCO-AM is also owned by ZBS.

On October 27, 2016, ZBS filed a 250-mile modification application to move K234CS to the Watsonville, California for the purpose of serving as a fill-in for KSCO-AM on proposed new Channel 300. See, *Application BMPFT-20161027AAK*. Application BMPFT-20161027AAK was filed in accordance with the Commission's *Public Notice DA 1491 (released December 23, 2015), Media Bureau Announces Filing Dates and Procedures for AM Station Filing Window for FM Translator Modifications and Availability of FM Translator Technical Tools*.

ZBS paid \$37,500 to acquire the K234CS Construction Permit and has every intention to complete this project. However, the underlying Construction Permit is scheduled to expire on January 31, 2017. Once the FCC grants modification application BMPFT-20161027AAK,

ZBS will need adequate time to order the transmitting equipment and install the same. ZBS submits that a modest extension of the construction deadline is not only in the public interest but also consistent with the Commission's AM Revitalization policies. Therefore, pursuant to footnote 36 of *Revitalization of the AM Service*, 30 FCC Rcd 12145 (2015), ZBS seeks waiver/tolling of the expiration deadline for at least six (6) months.

Also attached is a Declaration from the President of ZBS wherein ZBS commits to promptly construct BMPFT-20161027AAK.

Based upon the foregoing, ZBS respectfully submits that good cause exists to grant the tolling of the expiration of the Construction Permit.

Declaration of Michael Zwerling

Michael Zwerling, under penalty of perjury, declares as follows:

I am the President and 100% equity owner of Zwerling Broadcasting System Ltd ("ZBS"), the new permittee of unbuilt FM Translator Station K234CS, which has pending before the FCC modification application BMPFT-20161027AAK to relocate the translator facility to Watsonville, California for the purpose of serving as a fill-in translator for Radio Station KSCO-AM at Santa Cruz, California. ZBS is also the licensee of KSCO-AM.

ZBS recently acquired K234CS at a cost of \$37,500. Matching up K234CS with KSCO-AM (once the K234CS modification application is approved and implemented) will secure the long time viability of KSCO-AM. We will promptly order the broadcast equipment necessary to implement BMPFT-20161027AAK once that application is granted, and we will promptly arrange for the installation of that equipment so that the modified translator facility can commence operations at an early date. We are committed to this project.

Since the current expiration date of the underlying Construction Permit is January 31, 2017 we ask for additional time to complete this project. ZBS just recently became the permittee of K234CS. The upcoming holidays may delay the FCC processing of BMPFT-20161027AAK, and may also delay the scheduling of a tower crew to implement the modified facilities. Therefore, within the spirit of the FCC's AM Revitalization Proceeding, we submit that the grant of this extension request is justified.
