Note: Pursuant to Attribution of Ownership Interests, 97 FCC 2d 997 (1984), information has been reported only for those individuals who are officers and directors, and the single majority voting shareholder of Saga Communications, Inc. Each share of Class B Common Stock (which is held only by the single majority stockholder) entitles the holder thereof to one vote in the election of directors and ten votes on the other matters to be voted upon at the annual meeting of the corporation. Pursuant to *Review of the Commission's Regulations Governing Attribution of Broadcast and Cable/MDS Interests*, (MM Docket Nos. 94-150, 92-51, and 87-154), released January 19, 2001, the Single Majority Stockholder exemption was eliminated. However minority interests acquired before December 14, 2000, are grandfathered. If information regarding other stockholders of the corporation is required by the Commission, it will be supplied upon request.
