2. Paul A. Zevnik, the Secretary of Entravision Communications Corporation, also holds a 50% ownership interest (100% voting interest) in Biltmore (see above). He is the Secretary, Vice President and a director of Biltmore.

3. Univision Communications Inc. (“UCI”) holds a 28.44% ownership interest (0% voting interest) in Entravision Communications Corporation. UCI through two principal subsidiaries, Univision Television Group, Inc. (“UTGI”) and Telefutera, is the ultimate parent of the licensees of the television broadcast stations listed below. As a result of the recently completed merger with Hispanic Broadcasting Corporation, UCI has also become the licensee of 62 full-service radio stations and three FM translators. However, as set forth in the Commission’s decision in *Shareholders of Hispanic Broadcasting Corporation*, 18 FCC Rcd 18834 (2003), UCI’s radio station holdings are not attributable to Entravision and are not, therefore, listed herein.

I. Univision Communications Inc.

UCI is a publicly-traded company, and no single person or entity holds 33% or more of the debt/equity of the company. A. Jerrold Perenchio is the single majority shareholder, with an approximate 56.85% voting interest in UCI, following the share exchange resulting from the UCI/Hispanic Broadcasting Corporation merger, by virtue of the fact that his Class P common

stock is entitled to 10 votes per share so long as he continues to own at least 30% of the shares he held on October 2, 1996.

Grupo Televisa, S.A. and Venevision Investments LLC are shareholders of UCI which are each represented by a director on the Board of Directors and which are controlled by non-U.S. citizens. In addition, each entity holds non-voting stock and certain warrants which would allow it to increase its holdings to the extent that it is lawful for such a foreign entity to do so. In the past, the Commission has routinely approved interests such as these held by foreign entities. *See Univision Holdings, Inc.*, 7 FCC Rcd 6672, 6673-74 (1992); FCC File Nos. BTCCT-9606281ID through BTCCT-960628IN and BTCCT-960628IP through BTCCT-960682IV.

Certain officers and directors of UCI also hold positions as the officers and directors of the broadcast subsidiaries discussed herein. In addition, John G. Perenchio is the son of A. Jerrold Perenchio.

II. Univision Television Group, Inc.

TGI is wholly owned by PTI Holdings, Inc. (“PTI”), which, in turn, is wholly owned by UCI. UTGI is the sole owner and licensee of KUVE-TV, Green Valley, Arizona (FIN: 63927) and KUTH(TV), Provo, Utah (FIN: 81451).

TGI is the controlling general partner and PTI is the non-controlling general partner of the following licensee partnerships, which are the licensees of the indicated broadcast stations:
