The applicant, UCB USA, Inc. ("the Applicant"), is an Oregon non-profit non-stock corporation. The Applicant intends to operate radio station KDOV in accordance with the FCC's rules and policies governing non-commercial educational broadcasting.

The Applicant has dual educational objectives:

- To teach the Gospel; and
- To provide training in broadcasting skills to members of the local community.

The Applicant intends to use the radio station to advance its educational program by broadcasting biblically-oriented talk and musical programming, and by training members of the community in broadcast operations. In *Way of the Cross*, 101 FCC 2d 1368 (1985), the Commission made clear that noncommercial educational organizations, even though religiously-oriented, can satisfy the Section 73.503 eligibility standards.

A copy of the Applicant's Articles of Incorporation is attached hereto. It is respectfully noted that, on page 1, the "Type of Business" is "Christian Broadcast stations/programming/training and the Applicant's "Statement of Purpose" at Article 5A is "to teach the Gospel ... through a radio ministry." It is respectfully submitted that the foregoing is consistent with the Applicant's educational objectives and the Applicant's intention to use the radio station to advance its educational program.

Perry Atkinson, President, Director, and holder of a 20% voting interest in the Applicant, was from 1983-1994 the President of Dove Communications, Inc., which was formerly the licensee of KDOV.

Rev. Atkinson is uniquely qualified to lead the station's educational program. Holding a theology degree from Trinity School of The Bible, he is presently KDOV's General Manager and previously was Family Life Communications, Inc.'s Vice President for Broadcasting. He is Vice-President and Founder of Pacific Bible College; a former Associate Pastor at ministries in Ashland, Oregon and Sacramento, California; and a former bible instructor at Trinity School of The Bible. Highlights of his broad civic involvement include Federal candidacy for Oregon's 2nd Congressional District in 1994 and 1998; and past chairmanship of the Oregon Republican Party.

EXHIBIT "A"
ARTICLES OF INCORPORATION NONPROFIT

ARTICLE 5. OPTIONAL PROVISIONS:

A. STATEMENT OF PURPOSE

UCB USA, INC. is being formed with the goal of fulfilling the mission given by Jesus Christ to teach the Gospel and the things commanded by Jesus Christ through a radio ministry.

B. OTHER PROVISIONS

(1) This organization is organized exclusively for charitable, religious and educational purposes, the making of distributions to such organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal code.

(2) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose of this corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(3) The personal liability of each member of the Board of Directors and each officer and employee of the corporation, for monetary or other damages, for conduct as a director, officer or employee shall be eliminated to the fullest extent permitted by law.

C. The property of this Corporation is irrevocably dedicated to Section 501(c)(3) exempt purposes and no part of the net income or assets of this organization shall inure to the private benefit of any Director, officer, or member thereof or to the benefit of any private person.

ARTICLE 8. DISTRIBUTION OF ASSETS UPON DISSOLUTION:

A. Upon the dissolution and winding up of the Corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to (1) a nonprofit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in Section 501(c)(3) of the Internal Revenue Code and which has established its tax-exempt status under that section, or (2) to the United States of America, or to a state or local government, for a public purpose. Any such assets not so disposed of, shall be disposed of by the Circuit Court for the State of Oregon for Jackson County exclusively for such purposes, or to such organization(s) as said court shall determine, which are organized and operated exclusively for such purpose.
