Bela Broadcasting LLC (f/k/a Bela LLC) ("Bela") is a Florida limited liability company located at 7500 NW 72nd Avenue, Medley, Florida 33166. Bela is a board of managers-managed limited liability company with the following classes of members: Common Members, Series A Preferred Members, Series B Preferred Members and Series C Preferred Members. Presently, the only class of members holding attributable interests is the Common Members. One purpose of this application is to convert certain insulated members into attributable members with the power to influence Bela's affairs. Another purpose of this application is to permit an assignment of Matthew L. Leibowitz's Common Membership Interests in Bela to a single-member limited liability company, in which Mr. Leibowitz is the sole member and owner.

In BALCT-20040317ABX, the Commission approved an assignment of Station KBEH (f/k/a KADY), Oxnard, CA, from Bela to Bela TV, LLC, a wholly-owned subsidiary of Bela. At that time, the officers, board members and attributable owners of Bela were¹:
