Engineering Statement

This statement and the attached figures have been prepared on behalf of HBC License Corporation "(HBC L/C)", a subsidiary of Hispanic Broadcasting Corporation ("HBC") which through subsidiaries is the licensee of stations WOJO (FM), WVIV-AM, and WIND (AM) in the Chicago, Illinois area. HBC L/C proposes to acquire station WVIV-FM, Highland Park, Illinois. This exhibit also considers station WJTW(FM), Joliet, Illinois which HBC has entered into an agreement to acquire. These stations have overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations). An ownership study has been made in accordance with Federal Communications Commission rules.

The facilities of the stations under study are summarized in Figure 1.

The radio market applicable to the purchase of WVIV-FM is defined by the principal community contours of stations WOJO, WVIV (AM), WIND (AM), as shown on the map Figure 2. Station WJTW holds a construction permit for change in facilities, which provides a larger principal community contour than the licensed contour. The larger contour was employed for the ownership study (but the ultimate results of this analysis would be the same if the licensed facilities were considered).

The number of stations in a radio market is determined by counting the commercial stations having principal community contours, which overlap or intersect the principal community contours defining the radio market. The current facilities of stations WVIV (AM), WIND (AM) and WOJO (FM) encompass all of Chicago, the major city in the market. Including the anticipated acquisition (upon Commission approval) of station WJTW, HBC proposes to own or have an attributable interest in two AM and three FM stations in the Chicago area. As there are 13 AM stations and 14 commercial FM stations licensed to Chicago, the requirements of 47 CFR 73.3555 (which allow the joint ownership of as many as six stations, four stations in either service in radio markets with a total of 15 or more stations) are met.

The contours for AM and FM stations were determined employing the methods outlined in the FCC rules. Station information was obtained from the Commission's computer database.

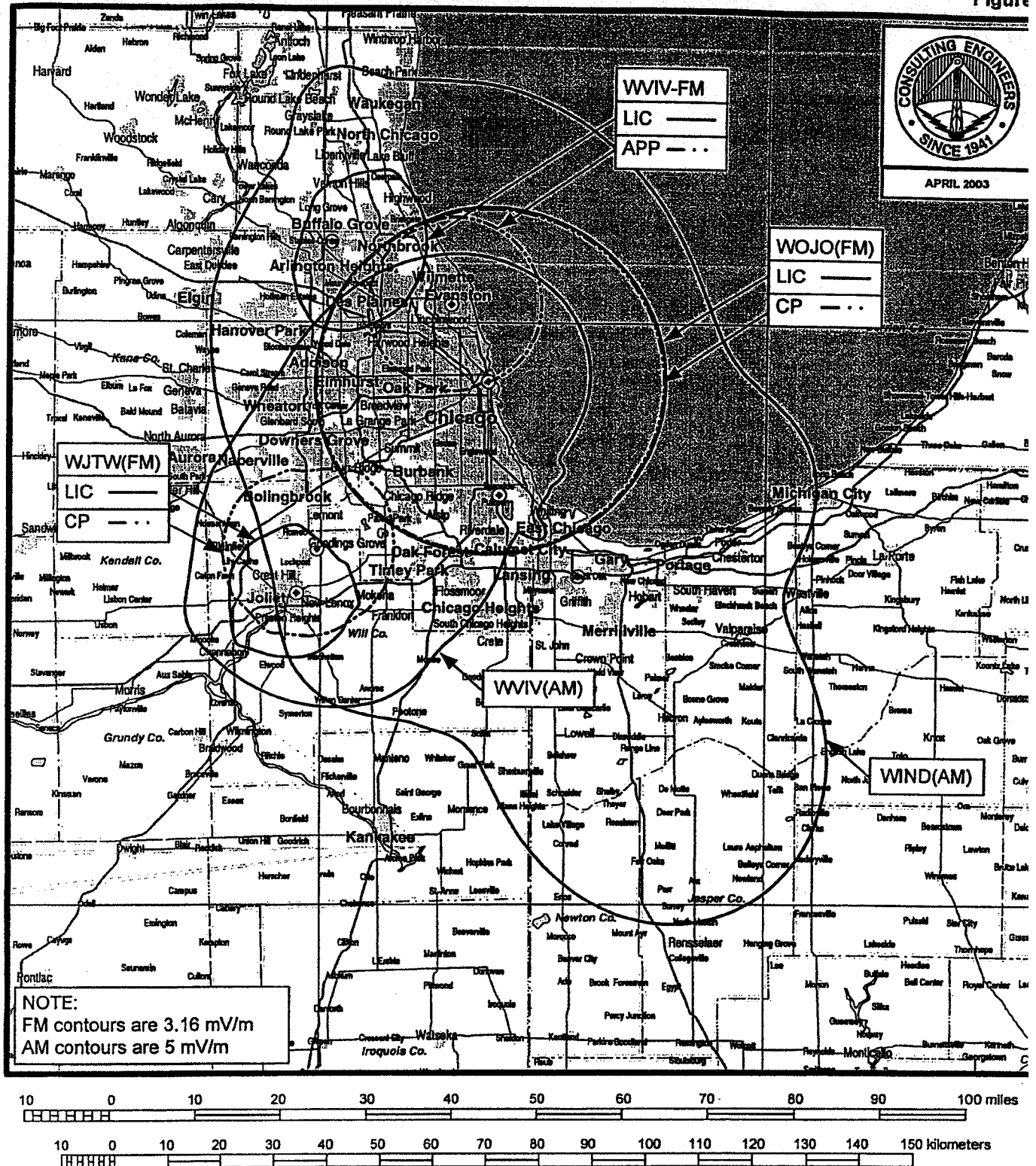
