

### **Description of Transaction**

Northwest Communities Education Center (“NCEC”), licensee of noncommercial educational station KDNA(FM),<sup>1</sup> Yakima, Washington, is a non-stock, non-profit organization. NCEC is filing this application to obtain Commission consent to a change in control of its Board of Directors that will arise as the result of an agreement into which NCEC has entered with Se-Mar Community Health Center whereby the members of the NCEC Board of Directors would, upon receipt of the Commission’s consent to the resultant transfer of control, be replaced by the members of the Sea-Mar Board of Directors. Sea-Mar is, like NCEC, a non-stock, non-profit organization and, as is set forth in the transferee’s portion of this application, a Commission licensee. Because this change in the NCEC Board will not be occurring gradually, but will take place in a single transaction, Commission consent is being sought on an FCC Form 315.
