

MULTIPLE OWNERSHIP RULE COMPLIANCE

Fox Television Stations, LLC (“*FTS*”) submits this Exhibit pursuant to, and in connection with, the Commission’s December 20, 2019 Public Notice announcing revised processing procedures for assignment applications on FCC Form 314.¹ This Exhibit corresponds to the application, as amended, requesting Commission consent to the acquisition by FTS of the licenses of television stations KCPQ-DT, Tacoma, WA (a Fox network-affiliated station); and KZJO-DT, Seattle, WA (a MyNetworkTV-affiliated station), each of which is located in the Seattle-Tacoma, Washington Nielsen DMA (“*Seattle-Tacoma DMA*”). This Exhibit supersedes Exhibit 18 of the initial application and demonstrates that the proposed assignment is in compliance with the Commission’s multiple ownership rules now in effect as a result of the decision of the U.S. Court of Appeals for the Third Circuit in *Prometheus Radio Project v. FCC*.²

Local Television Ownership Rules

Eight-Voices Test: As reflected in the chart below, nine independent full-power television “voices” will remain in the Seattle-Tacoma DMA after consummation of the proposed assignment.

Top-Four Stations Test: Based on Nielsen audience share data for the Seattle-Tacoma DMA, Persons 12+, 9am-12mid, for the period October 3-November 5, 2019, KZJO is not ranked among the top four stations in the DMA. Accordingly, the proposed assignment complies with the Commission's top-four stations test.⁴

Radio/Television Cross-Ownership: FTS does not directly or indirectly own, operate, or control any radio stations. As a result, the Commission's radio/television cross-ownership rules are not implicated by this contemplated transaction.

Newspaper/Broadcast Cross-Ownership: FTS does not directly or indirectly own, operate, or control any newspapers in the Seattle-Tacoma DMA, nor does the service contour of KCPQ or KZJO encompass the community of publication of any newspaper that FTS directly or indirectly owns, operates, or controls. As a result, the Commission's newspaper/broadcast cross-ownership rules are not implicated by this contemplated transaction.⁵

Attribution of Joint Sales Agreements: FTS has not entered into, nor is a party to, any joint sales agreements with respect to KCPQ or KZJO. As a result, the Commission's joint sales agreement attribution rules are not implicated by this contemplated transaction.

National Television Ownership Rule

FTS currently has attributable interests in stations that in the aggregate reach 25.0% of the national television audience, as calculated in accordance with Section 73.3555(e) of the Commission's rules based on TV household data from Nielsen.⁶ In addition to this application, FTS has filed an application for consent to assign the licenses of its television stations in the Charlotte, North Carolina Nielsen DMA, WJZY-DT, Belmont, NC, and WMYT-TV, Rock Hill, SC, to a subsidiary of Nexstar Media Group, Inc ("*Nexstar*"), and Nexstar has filed an application for consent to assign the licenses of its television station in the Milwaukee, Wisconsin Nielsen DMA, WITI-DT, Milwaukee, WI, to FTS. Upon the closing of all three of these proposed transactions, FTS would have an attributable interest in television stations reaching in the aggregate 26.5% of the national audience.
